To meet the development needs of young migrant workers in the field to maintain the stability of the current urban social development, it is very necessary to guarantee the development prospects of young people. The issue of livelihood has always been a major problem in the work of young migrant workers in cities. The root cause of this phenomenon is that their average level of education is low. It is difficult to apply for a position with a higher income. The general appeal of young migrant workers in the field is the need to pass certain vocational skills training to improve their personal qualities in order to achieve jobs with higher skill levels. The fundamental goal is to improve the working environment and raise wages. In turn, fundamental changes in the quality of urban life are realized. A small number of

III. THE NECESSITY OF UNIVERSITY LIBRARIES AND TOWNSHIP LEAGUE COMMITTEES TO SERVE YOUNG MIGRANT WORKERS

With the continuous development of the economy and the continuous expansion of the city, it is obviously a drop in the bucket to rely solely on the government to provide public services to young migrant workers. It is beneficial to improve their safety awareness and legal awareness, and teach them to use legal weapons to solve various problems encountered in urban life; third, establish a caring system and use advanced technologies such as multimedia to help young migrant workers solving their children's education problems and caring for psychological counseling activities to help young children working in different places to get rid of psychological barriers and environmental adaptation

problems, and solve the actual family problems of young migrant workers in different places.

V. CONCLUSION

To sum up, young migrant workers are the backbone of China's urban development and construction. University libraries and township league committees need to be closely integrated to help government functions to do a good job in extending social services, give full play to the special functional attributes of their own social organizations to establish a complete set of social service system for young migrant workers. Starting from the practical difficulties of working in the urban life of young people in different places, it helps them solving the various problems encountered in urban life one by one to meet the needs of stable social development and to maximize the benefits of urban economic development.
