Internet, as one great technology in the 21st century, is the centre of technology development in this era. Through the internet, the computer becomes more perfect than before. Computer with internet can be an important technology for communication. With both of them, communication begins to change to be Computer-Mediated Communication. This concept of communication is a great revolution in the communication field. The thing that is very dominant in Computer-Mediated Communication is the emergence of various forms of social media. Social media has its own advantages because, in social media, users have access to create their own profiles, know other user lists and interact with other users. The background of the emergence of social media is the need to make many people become connected to one another through a communication network. Ethic is one factor that sometimes, forgotten when the technology of communication become uncontrol. Bigo Live for example can be evident that technology has a degradation effect when technology is used uncontrol.

Global Village Concepts want to say that there are no more obstacles to time and place in communicating and exchanging information [1]. In the end, McLuhan predicts that there will be human dependence on technology, especially communication technology and information technology.

This is what McLuhan calls the Technology Determinism. The spectacular discovery that must be recognized until now and become the starting point of Global Village is the discovery of computer and internet technology. The development of new media is able to explore the role of new media in communities that have global networks [2].

Computers were first introduced by Charles Babbage in the 19th century [3]. Initially, a computer was a machine for analyzing that can do complex calculations at a time. The way to calculate in a conventional way began to be replaced by the role of the computer. In the next development, computers are increasingly equipped with functions other than counting. Computers began to replace typewriter functions in writing, this machine also provides convenience in editing and layouts that are more flexible than conventional typewriters.

The role of computers has developed very significantly when found in internet technology. This internet technology is able to make computer functions more optimal. Internet technology is a technology that uses computers and network systems so that using the internet can be connected to other computers. Is Leonard Kleinrock, a person who is referred to as the inventor of internet technology [4].

This situation is the potential for moral degradation.

This paper intends to present an explanation of Computer-Mediated Communication in the context of the development of communication technology. In particular, this paper will raise the phenomenon of Bigo Live, a communication technology that is loaded with elements of ethical degradation in communication.

II. LITERATURE REVIEW

Computer-Mediated Communication: Technology Revolution The concept of Computer-Mediated Communication according to Crispin Thurlow can be interpreted as an idea or design arranged in such a way as to facilitate the communication process of two or more people through different computers as media [5]. Of course, what is meant in this case is not the interaction of two hardware instruments (hardware), but rather on two or more communication actors who interact or communicate through an instrument called a computer by optimizing a program or application on that computer.

A.F. Wood and M.J. Smith explained Computer-Mediated Communication as an interpersonal or communal communication by optimizing computer and internet media [6]. In short, it can be said that Computer-Mediated Communication describes the behaviour of human communication using computer media that has been integrated with the internet.

Computer-Mediated Communication makes intermediary elements and direct elements in communication merge into one. Intermediary elements refer to an intermediary media in communication in both very traditional and more modern forms. Direct elements refer to face-to-face elements that occur in communication. However, today's technological

developments have built awareness that face-to-face elements are not an essential element in communication.

The thing that is very dominant in Computer-Mediated Communication is the emergence of various forms of social media. Intimacy is easier to develop through computer-mediated communication than face-to-face [9]. After seeing the description above it becomes clear that the second approach is the quantity approach. This

approach would rather state that computer-mediated communication helps communication people connect with more people both interpersonally and communally. It is undeniable that the phenomenon of Computer-Mediated Communication is a communication technology revolution.

This is what Marshall McLuhan calls the Determinism of Technology.

The phenomenon of Computer-Mediated Communication must be recognized as a necessity in the development of communication technology. This model of communication with computer mediation is inevitable, even though it ultimately creates a dependency. However, amid the uproar of

enthusiastic welcome at the presence of Computer-Mediated Communication, there is something that cannot be avoided, namely the emergence of scepticism on this matter. The presence of computers and the internet is seen as an instrument that will eliminate the human element in communication. The sides of the humanities in communication seem to be discarded by the presence of computers and the internet. In addition, the social aspects of communication are also seen as something that fades with the development of computers and the internet in the realm of communication. Communication participants are considered to have become antisocial because they are more likely to use computer media to communicate compared to face to face humanely. Apart from the scepticism in looking at the presence of computers and the internet in the world of communication, the positivism flow is far more dominant. The presence of computers and the internet, which built Computer-Mediated Communication, is considered to be an intellectual gift that is able to positively transform human civilization.

III. DISCUSSION

Even more concerning is that when on social media we find forms of communication that override noble values of humanity only to obtain a certain purpose. Pornographic uploads are one example of how people use social media without paying attention to the ethical elements of communication. This condition is very worthy of being referred to as ethical degradation in communication.

Bigo Live, a social media application that is currently in the spotlight of the public because it has been assessed as a social media that has experienced ethical degradation in communication. Bigo Live is an online application where users can interact with each other. Bigo Live has advantages compared to other online applications. Bigo Live can be witnessed by anyone even though they are not yet interrelated which in online interaction languages uses the word follow [19].

Bigo Live is noted as an application that is very popular and in demand by young people, especially in Indonesia. Bigo Live is an online video streaming site that was launched the first time in March 2016. The free Bigo Live application can be downloaded both on the Play Store and the App Store. Bigo Live was launched by a Singaporean company, Bigo

Technology PTE. LTD. which focuses its business on online video broadcast services. Bigo Live's popularity was marked by being the number one app on the App Store and Play Store in March 2016. The Bigo Live application according to Biagi was included in eight mass media businesses (internet). Biagi said the eight mass media businesses were (1) Books, (2) Newspapers, (3) Magazines, (4) Records, (5) Radios, (6) Films, (7) Television, and (8) Internet [20]. Strictly speaking, Bigo Technology PTE. LTD, as the company that launched Bigo Live, emphasized the company's vision as a company that launches applications that aim to build the largest live community in the world both for networking purposes and the purpose of partnerships in business. With this live community, everyone can interact audio- visual where and whenever. To achieve this goal, Bigo Technology PTE. LTD. formulate the following code of conduct:

1. Integrity
Conducting business ethically, credibly and full of service
2. Innovation
Always creating new ideas in running a business.
3. Transparency
Prioritizing the element of openness in carrying out business processes.
4. Broadcasting & Broadcaster
Broadcast and become a broadcaster on Bigo Live social media.
5. Real-Time Interaction and Mobile Streaming
Interactions run online and can be accessed anytime and anywhere.

With this code of ethics, it is clear that Bigo Live is not only launched as a live streaming-based social media for the sake of fun but is an application that can be used for business. Therefore, practically, Bigo Live is equipped with taking and give features which can eventually be compensated with a certain nominal value.

It is clear that Bigo Live was created for broadcasters to present themselves not only for friendship but also for business purposes. The take and give feature was made so that broadcasters were motivated to make interesting and profitable live shows but also stimulated the broadcaster to give an appreciation in the form of taking and give to broadcasters who performed interesting and useful broadcasts.

But, Bigo Technology PTE. LTD also realizes that there is always the potential for fraud in information technology and communication technology, including Bigo Live. Therefore Bigo Live applies a banned system. This happens when broadcasters broadcast something ethically inappropriate for broadcasting, such as pornography. Therefore Bigo Live establishes ethical rules in broadcasting:

1. It is prohibited to conduct broadcasting in the form of the spread of rumours, disruption of social order, and destroyers of social order.
2. It is prohibited to do broadcasting in the form of the spread of anxiety, pornography, gambling, violence, terrorism or incitement.
3. It is prohibited to spread slander or violate the rights

of others.

B. BIGO LIVE: ETHICAL DEGRADATION IN COMMUNICATION

A deviation takes place in the event of a practice that is against or contradicted with the original goal. Likewise, what happened with Bigo Live, an application that was originally created with a very good purpose that emphasized ethical elements clearly. This application complements itself with a system of sanctions for those who violate the code of ethics.

It is very ironic that applications that initially boast a strong element of communication ethics are actually applications that manifest an ethical degradation in communication. This began when Bigo Live did not have a strict control system in monitoring existing deviations. Bigo Live is now synonymous with pornographic elements that can be said as porn action. It is commonplace that Bigo Live users make sexuality a major commodity in broadcasting to get Diamond, a take and give a form that can later be compensated in certain nominal forms. It's not difficult to find in Bigo Live broadcasting from online users who intentionally exploit their bodies. Being a very ordinary spectacle in Bigo Live, a live woman wearing only underwear and a bra. Or there is even a woman who willingly performs sensual movements. Or even more extreme is that there are lovers who live on Bigo Live when they are in a relationship like a husband and a wife.

This condition is ultimately not only detrimental to Bigo Live but also a source of ethical degradation in a shared life. Noble sexuality is now a cheap commodity. This ethical degradation is also the potential for morality to be damaged, especially given the online nature, anyone has access to open the Bigo Live application. It is very inconceivable that the morality of society will be severely damaged by ethical degradation such as that caused by Bigo Live.

IV. CONCLUSIONS

Talking about technology can be said to be something that is always actual and develops no longer in a matter of years, or months, or days, or hours. Current technological developments can be said to be changes that occur in seconds. It is grateful that the human civilization of this era has achieved an intellectual development that is capable of producing various forms of technology that can eliminate communication constraints. Technology has made this vast world become a narrow world village. Only one thing that should not be forgotten is that technology not only has positive effects but also negative effects. Therefore there needs to be a clear attitude in facing the pace of development of information and communication technology. In other words, technology must be under our control as humans.
