Due to the division of disciplines, time may be of great concern to historians, space may be of great concern to geographers, and social theory researchers have greatly ignored these aspects ."[3]He advocated the thought of time and space as the core of social theory. In the traditional society, time and space are closely related, people understand time by

the specific relationship between the places where the actors are present, the scale of time and the place of social action are connected with the characteristics of the action itself.Giddens first discussed the dialectical way of spacetime separation. The separation of time and space means that, on the one hand, the appearance and unity of clock and calendar, time can be clearly and clearly reflected in the subjective world of social subject and exist as an objective thing. On the other hand, the appearance and precision of world map and the invention of science and technology make space independent of any particular place and area and breed elements for lack of field. According to Giddens," the clock embodies a unified scale of "virtual (empty time)" time," and" the development of "virtual space" can be understood from the angle of separation between space and place ".[4]This kind of time vacuity and space vacuity finally point to a kind of globalization, is a kind of time and space unification and standardization in the global scope. Giddens also dialectically analyzes the separation of time and space. Space-time separation is not the ultimate destination of space-time order, but is recombined in some social activities according to the subjective needs of social subjects, thus crossing the vast space-time tunnel. The separation of time and space is the union of social relations across the vast field of time and space, and up to the state of the global system.[4]

Harvey has argued deeply about space-time compression," a term that marks processes that revolutionize the objective qualities of space and time so that we are forced, and sometimes quite radical, to change the way we present the world to ourselves ". Space-time compression means the acceleration of social concentration, efficient and fast. Space-time compression is accompanied by space-time expansion, which is reflected in the large-scale expansion of life stock, geographical space range, human behavior and lifestyle, and living space.[6]

In the rapidly rising network society, this separation and reorganization of space-time and the formation of spacetime compression and space-time expansion on this basis are more extreme. First of all, network communication gets rid of the "synchronicity" and "presence" of "face-toface" communication in real society, that is, it gets rid of the limitation of time and breaks the obstacle of geospatial distance. Giddens thinksThrough the separation and reorganization of time and space, and the mechanism of delocalization and institutional reflection established on its basis, modernity has developed rapidly and has become a worldwide system with the extension of time and space.[2]According to Giddens, modernity refers to "social life or form of organization, which appeared in Europe in about the 17th century and, in later years, influenced in varying degrees around the world ",[2]In its simplest form, modernity is an acronym for modern society or industrial civilization. During the middle and late 20th century, with the increase of globalization and the introduction of high-risk parameters, Giddens believes that a new modernity reflect on the emergence of modernity, which marks the development of modernity from the early stage to the late stage, the end of the industrialized society and the beginning of the post-traditional society. Giddens believes that space-time separation and its formal recombination are one of the main driving forces of modernity. Spatiotemporal separation is the initial condition of the delocalization process. The so-called "dissociation" or "deintercalation" of social system generally refers to the social relations "dug out" from the interactive regional or local scenes, and makes the social relations "reconnected" in the infinite space-time zone. specifically, giddens distinguishes between two delocalization or delocalization mechanisms: symbolic markers and expert systems. Symbols or symbols are "the medium in which information is communicated without taking into account the particular qualities of individuals or groups that process it in any particular scenario ."[4]For example, as a pull-off mechanism, money is a tool of time and space extension. At the time level, money is a means of credit. Spatial level, it can get rid of the space-time directness of material transaction. In short, money makes it possible to trade between people separated in time and space, making the chain of trading behavior longer, allowing and facilitating a wider exchange.

Habermas mentioned in Modernity and Massacre that modernity is inseparable from the development of science and technology, rational calculation and stratification.[7]The space-time logic of network society embodies the modernity characteristic of science and technology and rational calculation. Network society is one of the results of the development of modern society. The space-time experience of network society expresses



the deep control of time and space by modern people. Behind this control is the further pursuit of efficiency in modern society. We say this is an important embodiment of modernity.
