

# Technology Becomes a Learning Problem During the Covid-19 Pandemic

them have difficulty when lectures are carried out online. They have complained a lot with various factors including lack of network and constrained data packages

The purpose of this study was to obtain information about the impact of COVID-19 on Indonesian Language and Literature education students, Bung Hatta University, Padang. What are the impacts felt by these students with lectures being conducted online and whether online learning is effective?

Online classes in COVID time are costly. There are several things to consider for better teaching in the online classroom learning process. Recorded videos can help with learning if the internet connection is delayed. Furthermore, the challenge of online learning is the availability of internet services. Some students access the internet using cellular services, and a small proportion use WiFi services. When the online learning policy is implemented at Bung Hatta University, students return home. They experience cellular signal difficulties when in their respective areas, even if there is a signal they get is very weak. This is a challenge

in itself in the application of online learning at Bung Hatta University. Online learning has weaknesses when internet services are weak, and lecturer instructions are poorly understood by students

### ***3.2. Students need a lot of data packages and costs for learning during a pandemic***

In the current pandemic, all elements of education carry out online learning. They need a lot of data and costs in accessing all the assignments given by the teacher or lecturer concerned. The use of smartphones and laptops in online learning can improve student learning outcomes. There are many advantages of using information and communication technology in implementing online learning. between them is not bound by time and space. Many studies have been conducted that examine the use of devices and laptops in learning. The ability of devices and laptops to access the internet helps students to take part in online learning. The use of online learning using zoom cloud meetings has the advantage of being able to interact directly between students and lecturers as well as teaching materials but it has the weakness of being wasteful and less effective if there are more than 20 participants. Because not all locations where they live are covered by signals. Second, students need data or a lot of money to buy data packages to study online, this is an obstacle because not all student economies are adequate, during the Covid-19 pandemic, students objected to paying large fees to buy data packages. Third, students do not understand the material presented by the lecturers in online learning. as a result, online learning is not effective and conducive.
