

Policy of District Government of Poso in the Prevention of Terrorism

ABSTRACT

This research aims to illustrate and analyse the policy of the local government of the Poso district in the prevention of acts of terrorism by using qualitative descriptive methods. Data obtained by using interviews and library and document studies. The results showed that the local government of Poso district made a policy of preventing terrorism action by forming a Harmony village, and then the local government of Poso Regency formed the early awareness Forum of the district level Society, then the local government of Poso district implemented Awareness activities that contradict the values of Pancasila, and the local government of Poso Regency provides social assistance to the poor and family terrorism prisoners and the Indonesian Alliance of Peace together with the government. The district of Poso provides entrepreneurial training to former terrorism convicts. Based on the results of the research, the local government of Poso district made a policy that was handed down in local regulations on counter-terrorism in the Poso district.

1. INTRODUCTION

Terrorism is an attempt to use violence or threats to society or the security of the country in different ways, resulting in security disruptions and fears and even a fall of casualties. Terrorism was initially the centre of the world's attention after an event of 11 September 2001 in the United States. This thrilling event is a very grievous tragedy for the people of the world. The accident with four violent suicide bombing attacks killed approximately 3000 people. The sudden death that makes paralyzed life in the largest city of the United States, is certainly a crushing blow to the trust of citizens to the United States Government of the national security system [1]. Terrorism is all the actions of a person who suddenly uses violent or threatened violence, and makes the atmosphere chaotic and creates fear of others, and makes them fall of Mass casualties and also usurp the freedoms of others. 2 The Southeast Asian region is an area that is very or always in the act of terrorism since the presence of the Al-Qaeda military branch in December 2001. The branch named Pilgrims Islamiah (JI) operating in Singapore, Malaysia, and Indonesia which shows the transnational operating model of the Congregation Islamiah (JI) to add a list of security threats in Southeast Asia that often experienced A ethno-private separatism rebellion in religious conflict (such as Rakhine Aceh,

Poso, Maluku, and Papua). Some Southeast Asian terrorist groups have been associated with al-Qaeda propaganda, member recruitment, raising funds, and bomb attacks [2].

Currently, the map of the Indonesian Islamic radical group is broadly divided into two related affiliates against transnational radical organizations, the first anti-ISIS (tends to pro-Al-Qaeda) and supporters of ISIS. The anti-ISIS ranks there were groups of Indonesian Mujahidin assemblies, HASI, Ansharut Syariah worshippers (the shards of JAT) and pilgrims Islamiyah. The fortress supported ISIS, among others, pilgrims Ansharut Tauhid, IN Makassar, East Indonesia Mujahidin, KOMPAK, Ring Banten, West Indonesia Mujahidin, FACTION, Al-Muwahidun, Al-Mujahirun and Tauhid Wal Jihad [3]. The beginning of the act of terrorism in Poso was after the communal conflict in 2000, it triggered the coming of mujahidin groups ranging from jihadis, pilgrims Islamiah (JI), Mujahidin Kompak. Poso is a regency with a small population and less known to the crowd, gaining the spotlight of the international world as one of the most important operating places of the Jemaah Islamiah terrorist network. The terrorist network has the priority of recruiting local youth and giving military training to launch acts of terrorism [4].

There are several cases of terrorism that the authors expose in this study, the first, the case of the suicide bombing Mapolres Poso on Monday 03 June 2013, the perpetrators-who came to the Poso Mapolres using a motorcycle was rebuked by the officer, but continued to cross the post and the bag of the perpetrator explodes. Secondly, an assembly bomb explosion occurred in the village of Dewua, Poso District South coast and the shooting of police officers who came to the site after the incident. Thirdly, ambush and assault 3 villagers Tamadue, District Lore Timur, Poso District, occurred on Saturday 27 December 2014, ambush and attack carried out a group of armed people who were suspected terrorists. The fourth, sadistic murder 3 villagers Tangkura Coastal Poso district, occurred on Thursday 15 January 2015. Conflicts and violence are useful for the violence of conflicts as the following concepts; A) an indication of violence at the threshold of violence occurring every morning, evening even during the day, violence occurring in the crowd, excessive fear of society, the apathy of society and not dare to prevent violent action, increased Number of cases of violence, b) the cause of violent factors such as the effort to retain power, the emergence of strong economic groups, increasing the increase, the emergence of hunger and poverty, C) as well as the form of physical conflicts such as mass amuk, riots Demonstrations, bombardment, inter-group warfare and physical terror [5]

The challenge of dealing with terrorism convicts or members of a skilled terrorist network takes advantage of the opportunity, the deradicalization program requires many approaches according to the characteristics of the radicalization process occurring and experienced. Specific person or group. The implementation of the deradicalization program stems from the understanding that terrorism begins with the process of radicalization, to fight terrorism, it is more effective by disconnecting the radicalization process. Regarding the process of radicalization is the process of understanding or mindset that confirms the enforcement of violent action, then what should be done is to correct the thought according to the background that formed it through Different approaches based on their respective causation factors. Thus, combating terrorism through deradicalization programs will certainly differ in every region and every country [6].

The act of terrorism in Poso is not only a matter of the central government but also the problem of all elements of Poso regency. The act of terrorism in Poso, rooted from the lower community to the top of the community, the impact is to interfere with the Government and the order and security of the Society of Poso District. Therefore, the local government of Poso regency needs to prevent terrorism action that touches the whole layer of society. If the acts of terrorism in the Let, are not prevented and not taken captive, even allowed to present in the community, while tolerance and nationalism only

become slogans, then acts of terrorism by terror groups is precisely being cultivated more fertile and May pose a conflict in the community.

The policy of the local government of Poso regency in the prevention of acts of terrorism by improving order and security seen in the local government Law No. 2 of 2014 Article 12 paragraph 1E, mandatory governmental affairs relating to the Basic services are peace, public order, and community protection. After Santoso was killed, the safety condition in Poso began to say safe and peaceful. It was said by the regent of Poso that the safety condition in the Poso district has been good, the community has felt safe in the move on. The order and security are a political pledge that is contained in the vision of the district government of Poso 2016-2021 "The realization of the regency of Poso, the peaceful, fair and Sejahtera supported by reliable and dignified human resources". The strategy of the local government of the Poso Regency to restore public confidence in the security condition of the Poso district with a way to boost tourism potential in the form of cultural preservation, cultural events or cultural promotion [7].

Then, he pressed on increasing terrorism acts that could result in security disruptions, police and local government of Poso in cooperation with religious leaders, and scholars to prevent the activities and recruitment of radical groups Terrorism for the lives of people in Poso. Also, the institution of civil society Strengthening (LPMS) of Poso District, conducted an improvement training for civil society in support of reintegration and social rehabilitation for former perpetrators of extreme violence. The event was attended by Pemda Poso, religious figures, FKAUB, NGOS, police, Alkhairaat, Muhamadiyah, and students. The Workshop will later give birth to recommendations that can be used as the concept guideline by all parties of local governments, security personnel, civil society groups, religious, NGOS in the prevention of the dissemination of radicalism [8]. It can be understood that some local government and non-governmental efforts have not been said maximum, it is in because there is still 7 list of people's Search (DPO) Santoso members who Haven't been caught yet. The seven remaining DPO is the target of hunting. This makes the community become restated and the condition of order and security is disrupted.

From the background description above, the local government of the Poso Regency needs to have a very strategic policy in the Prevention of terrorism action for the creation and security in the region of Poso district, because of the region of Poso District Otomoni area in which there is a government system. Therefore, local governments must build relationships with related institutions to create order and security conditions in the district of Poso. From such cooperation will be born many of the efforts to prevent significant acts of terrorism

in the life of the community of the Poso District in general. This effort will be created to the social regularity in the Poso regency.

2. RESEARCH METHODS

This research was conducted in Poso district, to get a deep understanding of the policy of the district government of Poso Prevention of theism. Researchers use qualitative research methods with a qualitative descriptive approach. Qualitative research is research that is intended to understand the phenomenon of what is experienced by the subject of research (Moleong) while the informant is a person who can provide information about the situation and conditions about the thing researched. The data required in the study is primary data and secondary data. In this study authors data collection using interviews with the objects being researched. In conducting research data analysis refers to several phases consisting of: data reduction, data presentation, in the final stage is the withdrawal of conclusion or verification (conclusion drawing/verification).

3. DISCUSSION

3.1. Recommendation by the People's Representative Council of Poso

Before According to Barry Buzan, securitization also includes social security. Social security, including the ability to maintain and produce traditional patterns in the fields of language, culture, religion, and national identity [10]. The local government of Poso regency together with the Ministry of Religious Affairs of Poso Regency formed the village of Harmony, in the village of Harmony of the local government to empower the extension of religious extension of the Forum harmony of the religious people, this extension Served to provide enlightenment to the people of the village Tambarana and Kalora about the harmony of religious people. The above results also by an understanding that the harmony is an uncontradictory and peaceful peace that should make a living with each other, the United Heart, the Sling agrees to create a life of peace and Sejahterah [11].

3.2. Early Detection

According to Barry Buzan in securitization, actors perform mapping on the condition that occurs, the constellation of securitization (constellations of securitization); Mapping process related to regional security, which aims to analyse the security linkage pattern of several different security complexities [10]. In line with the opinions of Barry Buzan on the prevention of terrorism efforts conducted by national preparedness through Community empowerment, improvement of apparatus capabilities, protection and improvement of infrastructure, development of terrorism studies, as well

as mapping radical vulnerable terrorist areas [12]. The results of the research field mentioned that the local government of Poso district made early detection in the task of the district-level intelligence community. Then the unity agency of the National and political district of Poso formed the early vigilance Forum of society in 11 sub-districts. The findings in the field that the member of the Forum early vigilance of the community of Poso District South coast gathered information from the community that there is a hostage event against 2 villagers Sangginora, then give reports to the parties The regional intelligence community then reports it at the follow up by the regent of Poso. Then according to Barry Buzan in the securitization of actors performing military security, includes interactions between two levels and strengths, namely defensive abilities and Perceptions of each party's intentions [10]. The results of research in the field found that the TNI/POLICE was building a security post at the entrance of Sangginora village, this aims to record the citizens who enter the village to anticipate the movement of the terrorist group.

3.3. Development of religious harmony

The efforts of the local government of Poso regency in the prevention of terrorism in Poso by the results of the research of local governments through the national and Political union of Poso District conducts security on the social and political sectors. According to Barry Buzan, Social security includes the ability to maintain and produce traditional patterns in the areas of language, culture, religion, and national identity [10]. Researchers found that the local government of Poso district through the body of unity and politics carried out social security by the prevention of acts of terrorism by carrying out counselling activities in the field of religion, involving Party of FKUB. This counselling activity FKUB provides understanding to the community about religious values and the importance of maintaining harmony among religious people. As well as national identity, Kodim 1307 Poso and Poso Polres provide material about the counselling of the understanding that contradicts the Pancasila ideology and controls the Pancasila as an ideology of nation and state. Then the nation's unity and political bodies do the prevention of actions by conducting political security, namely: covering the continuity and stability of a country's organization or system of government and ideology that legitimizes these two things. The local government of Poso regency through the national unity and political resilience sector to make a development program for religious people to be implemented by implanted into the knowledge counselling activities contrary to the values of Pancasila. This activity is performed continuously every 3 months during 2017.

3.4. Improved social welfare

Use According to Barry Buzan, the security referred to in securitization is not limited to security only, but it covers economic security. Economic security, including access to financial and market resources necessary to maintain the level of welfare and strength of the country. The implementation of terrorism prevention with an economic security approach supported by the view of Darcy Noricks in the concept of deradicalization with an entrepreneurial approach, the entrepreneurship approach has a major role in the implementation of deradicalization. The business world can create jobs, reduce unemployment, increase community revenue, and increase productivity. Also, the business world has an important role to make the community more creative and independent. The social service of the Poso District assists in the construction of habitable residential homes to underprivileged communities and families of terrorism convicts. The social service of the Poso Regency involved the TNI in the construction of a habitable residential house, the TNI involvement is the duty of the TNI through the territorial operation. This territorial operation aims to help restore the security situation that is long enough to be disturbed by the threat of terror action, radicalism, and other security disruptions so that Poso is again conducive to the development of the National Program and help the local government to the welfare of its people. Then the social service of the Poso District was supported by the civil society strengthening the institution of Poso District to assist former terrorism convicts that are packed in the program quality Improvement of service facilities & rehabilitation Infrastructure Social welfare of the PMKS. The social assistance is appropriate in the form of business assistance to the former Narapiand terrorism that is displaced in the KUBE (Joint business group) goal is to have the former terrorism convicts have a special skill in building the economy to Sustainability of their lives. The assistance provided by the social service of Poso District is sourced from the budget income of Poso Regency and the state expenditure budget.

3.5. Entrepreneurship Training

According to Barry Buzan's opinion, the process of securitization is done through the security Analysis Unit (the Units of security analysis: Actors and referent objects); That is the actor who is referring to securitization (country or community). Indonesia Peace Alliance Jakarta is the main actor in the training of strengthening efforts for former terrorism convicts, Indonesia Peace Alliance Jakarta allows ex-convict terrorism in Poso to give Training, to have entrepreneurial skills in living a new life after exiting the correctional institution. Self-reliance is to train and foster the former prisoner preparing skills and expertise, the point is that they come out of correctional institutions,

they already have the expertise to open the job field. While personality coaching is an approach to dialogue with terrorist prisoners so that their minced can be straightened and have a comprehensive understanding and can accept different parties. This Program will provide for them in living life after exiting the correctional Institution [13]. In this case, the policy of prevention of terrorism in the Poso district conducted by the Indonesian alliance peacefully Jakarta, involving the local government, namely the deputy regent of Poso Yang in the Act to open the activities and as a speaker in the activities Strengthening business training for former terrorism convicts. The above results also by the understanding of Syahrin Harahap, in the policy of prevention of terrorism need an equitable government and the welfare of the people, and keep in order not to pay them the disparity of prosperity. Therefore, efforts to create programs Governments and more concerned about the sufferings of the people became a necessity [14].

4. CONCLUSIONS

Security recommendation of the People's Representative Council of Poso Regency resulted in a rapid pace of local government of Poso regency along with the Ministry of Religious Affairs of Poso regency forming the village of Harmony and placing the extension of religion from the harmony Forum of the People In the district of Poso, the local government of Poso Regency, in the prevention of terrorism District of Poso Regency, formed 11 early vigilance Forum of district-level community and made security post in Entrance of Sangginora village. In addition, the development of religious harmony, the prevention efforts of terrorism conducted by the local government of Poso regency by carrying out the counseling activities that contradict the value of Pancasila, then the local government of Poso Implementing the improvement of social health, social service provides social assistance to the community and family of former terrorism convicts, namely the construction of habitable homes and assistance to 4 business groups with ex-convicts Terrorism, as well as entrepreneurship training, the local government of Poso district in collaboration with the Indonesian Peace Alliance Jakarta conducted entrepreneurial training to former Narapiand terrorism in Poso, the results of the activities, one of the former Narapida terrorism has a business as a director of short filmmaking, and is proving to add to their revenues and evidently.
