4. OPTIMIZATION PATH OF ONLINE PUBLIC OPINION RISK

At present, the planning and risk optimization of China's online public opinion is still at a preliminary stage, and there are more problems that need to further improve the effectiveness and rationality of the risk optimization path to ensure its normal effectiveness.

4.1. Do a good job of public opinion warning to strengthen the positive guidance of online public opinion
