

## Ideological and Political Teaching Practice of Specialized Curriculums Under Mixed Teaching Mode

Take Investment Prediction and Decision as an Example

Domestic scholars have reached a certain consensus on the hybrid teaching mode, believing that this new teaching mode is not only a combination of multiple teaching methods, but also an effective organization of various teaching elements. It is a combination of the advantages of offline traditional teaching mode and online network teaching mode. The hybrid teaching mode is not an arbitrary "online + offline" teaching, but takes full account of the learning needs, learning state and psychological needs of the objects of education in the teaching effect. Compared with the traditional offline teaching mode, the hybrid teaching mode can not only save teaching resources, overcome the constraints of time and space, effectively improve teaching efficiency, but also play a significant role in stimulating students' enthusiasm and creativity in learning and stimulating the motive force of learning.

#### 2.4 The Construction of Ideological and Political in the Curriculum of Investment Prediction and Decision in the Hybrid Teaching Mode

Teachers before class to import this part, you can let the students after class to collect Warren Buffett studying experience, investment experience. Berkshire hathaway operation, charity dinner, such as content, guide the student to feel no pain, no gain, there is no such thing as a free lunch, keep in mind the heart of thanksgiving, always be grateful to life. As another example, teachers in the teaching of factor analysis, requests the student to advance through the online platform to watch "the power of the company" documentary, before class to guide students to think, such as lenovo group, cnooc, Air China, such as the development of China's typical company, is to promote national progress, and only the strength of national can more deeply affect the country's social, economic, national and even the thought. Then the socialist core values education is introduced to gradually inspire and train the patriotic sentiment of college students, and establish the correct world outlook and values. At the same time, the students understand that the above analysis is the full embodiment of the dialectical relationship between matter and consciousness in Marxist philosophy. Again, such as, the bond part of preparation before class, the teacher can let students in online platform to watch the video where the European debt crisis, according to the basic characteristics of the bond, the credit risk, such as Greece's sovereign debt crisis content, emphasize the big to the country, the small to the importance of personal credit maintenance, told students integrity is a kind of invisible power of the individual, it is an intangible wealth to advocate college students to be an honest and trustworthy person.

## 2.4.2 In the Class of "Integrating Morality into Education" Teaching Link

As the central link of the teaching activity of "Investment Prediction and Decision", the teaching link of "integrating morality into education" is related to the results of all teaching activities and constitutes the key link of the whole teaching process. To manipulate the market in the news, for example, the teacher first let students understand the case before the class background, students in the class import link will issue published on designated online platform, learn in the class, to teach students about the news of

private equity funds, market manipulation, insider trading, illegal operation and other professional knowledge. After that, answer the online questions published by students before class in class. According to students' learning status and the extended learning resources published by teachers in advance on the internet, teachers will raise relevant questions in class and let students post answers and discuss on the online learning platform. Through the "offline + online" learning in class, the case triggers students to think further, and trains the economic statistics major students to establish the correct outlook on life and values. Taking Gree Air Conditioning, a Chinese national brand, as an example, the video Gree Innovation Changes the world is played on the teaching platform in the middle of the class to guide students to pay attention to the phenomenon of increasing corporate value brought by technological innovation when evaluating the fundamentals of stocks. Through the case study of Gree Electric Appliances, we can understand that as the world's largest professional air conditioner manufacturer, Gree Electric Appliances, a listed company, has become the benchmark of independent research and development and independent innovation in China, so that students can feel national pride. In addition, in the hybrid teaching mode, teachers can also incorporate ideological and political education into the teaching of specialized curriculums by listing many classic cases: As in the list of "Belt and Road Initiative" investment opportunities, and then extended to Xi Jinping, general secretary of the proposed theories such as "building human destiny community", guides the student to realize "Belt and Road Initiative", "human destiny community" is a reflection of Marxist Materialist dialectics, anything, any country can't exist in isolation, too, The whole world is an interconnected, unified whole, countries influence and relate to each other. The governing policy to not only pointed out the direction of human civilization, more enriched and developed the Marxism theory system, founder group due to the diversity of blind expansion of debt, a default by the bankruptcy reorganization, through on-line case study, Offline guide the student to be like a business enterprise, to recognize yourself, pay attention to the moderation, be rational, cannot too greedy, otherwise you will lose yourself, using the treasure to acquire Vanke's treasure dispute cases, recommended students through online platform to read electronic books "the barbarians", and thus inspire students, no matter how much success can't be proud, always be prepared for danger in times of peace; When explaining the science and technology Innovation Board, it is necessary to point out that the science and technology innovation Board was first proposed by President Xi Jinping at the opening ceremony of the first China International Import Expo on November 5, 2018. The successful establishment and operation of the science and technology Innovation Board has fully verified the rationality and applicability of the socialist economic thought with Chinese characteristics for a new era. In order to enhance students' self-esteem and confidence in the country. What's more, teachers can also track students' learning progress in real time according to the online learning platform and use the online testing function to understand students' mastery of classroom knowledge, which can also be used as one of the assessment criteria for the process evaluation of teaching activities.

#### 2.4.3 After Class "Integrating Morality into Education" Feedback Link

The last link of the teaching activity of Investment Prediction and Decision is the feedback link after class, which can timely reflect the "teaching and learning" effect of teachers

On the one hand, after each section and chapter of "Investment Prediction and Decision", teachers use online teaching platforms such as Super Star Learning Tong, micro teaching assistant and Dingding to test students online in different question types. Then guide students to learn to reflect and summarize, so as to achieve the dual goals of value shaping and ability cultivation for students majoring in economic statistics while cultivating their logical thinking.
