

## The Protection and Improvement of Music Copyright in the Chinese Market from the Perspective of Music Education and Policy Administration




Fig. 1. Top three judgments related to infringement in the field of online music in China [11]

#### Promoting Academic Achievements and Teaching Staff in Music Copyright Law

On the other hand, we should promote academic achievements in the field of music copyright law, promote the exchange of experience in teaching music copyright law, and actively cultivate full-time teachers for teaching music copyright law. It is also possible to recruit part-time teachers who have been teaching long-term judicial practice or legal education [9]. Music copyright law should also be taught as a subject in popular music education so that people are aware of the importance of music copyright.

Through the introduction and understanding of intellectual property law, art law, music copyright law, and other courses, people should pay more attention to the respect of copyright and develop a sense of respect for copyright. Through popular music education, people should develop the concept of respecting copyright, respecting creators, and protecting the rights of creators from themselves, so as to solve the problem of confusion and abuse of illegal media in the music industry.

#### **5.2 Popularizing Relevant Public Policies**

From the public policy perspective, first of all, legal publicity and education should be strengthened to enhance citizens' awareness of copyright. There is a Chinese saying that knowing the law is the only way to abide by it. It is necessary to strengthen citizens' understanding of music copyright as well as their understanding of relevant systems and regulations so that they can consciously protect music copyright in their lives and

avoid some unlawful ways and practices. In order to strengthen legal publicity and education, the National Copyright Administration can regularly convene music copyright popularization seminars in various cities and communities, so that the grassroots can have a more thorough and deep-rooted understanding of music copyright.

In addition, the government should further improve music copyright-related laws and regulations and increase penalties to avoid the problem of taking copyright laws lightly because the cost of crime is too low, for example, by establishing a reporting mechanism so that the public can have a way to report infringing content that is frequently distributed and thus punished. At the same time, China's National Copyright Administration and relevant public institutions should strengthen special rectification of copyright of audio-visual works, for example, by strengthening the supervision of the Internet, especially various e-commerce, online education, and various social networking platforms. The government should also strengthen its organizational leadership, and competent departments at all levels of copyright, communications, public security, and Internet information content should establish a sound comprehensive governance system for combating copyright infringement and piracy online. Making the Internet a good medium can promote the development of music and the dissemination of music products. We cannot stifle the development of pirated music and various infringements on the grounds that the Internet is weakly managed and extensively regulated.

#### 6 Conclusion

With the great prosperity and development of culture, art plays an important role in cultural undertakings by leading the mainstream ideology of society, and the cultural industry is increasingly assuming the role of a pillar of the national economy [10]. Music is an indispensable part of the cultural industry. And the importance of music copyright should be fully realized. Besides, the paper indicates the best way to protect and improve music copyright in the Chinese music market is to strengthen the awareness of copyright protection, especially among music professionals and musicians, by innovating the concept of music education and the methods of music education.
