

# Improving Entrepreneur Competency for the Entrepreneur Community Using The Triple Helix Approach

Abstract. Triple Helix is an approach to developing a knowledge-based economy that encourages collaboration among three actors: academics or universities, government, and business or companies. The purpose of this research is to describe the pattern of using the Triple Helix approach to increase the entrepreneurial competence of the Laweyan batik entrepreneur community, as well as to describe the Triple Helix approach used by Academics, Government, and Entrepreneurs to improve entrepreneurial competence for the Laweyan batik entrepreneur community. A qualitative approach with an ethnographic design was used in this study. As the Triple Helix actor, the informants in this study included the head of the Laweyan batik entrepreneur community, academics, businessmen, and the government. Interviews, observation, and documentation were used as data collection techniques. The validity of the data in this study was determined through source and technique triangulation. The interactive analysis technique of the Miles, Huberman, and Saldana models was used in this study to analyze data. The findings revealed that: 1) academics, entrepreneurs, and the government can be connected and collaborated based on their respective capacities and capabilities, so that it can become a cycle that fills each other's roles in innovation and creativity, so that historical and cultural tourism in Kampoeng Batik Laweyan becomes a supporter of the regional economy; and 2) Triple Helix actor synergy in the development of the batik industry to improve entrepreneurship. As a result, Triple Helix actors can collaborate to develop a program for business assistance that lasts at least one month in order to improve the entrepreneurial skills of the Laweyan batik entrepreneur community.

Kampoeng Batik Laweyan is a popular collection of batik entrepreneurs' villages in Solo. The attractiveness of Kampoeng Batik Laweyan includes socioeconomic conditions, cultural heritage conditions, and batik industry conditions [1]. The Kampoeng Batik Laweyan Development Forum (FPKBL) manages Kampoeng Batik Laweyan as one of the efforts made to manage destinations so that the batik industry in Kampoeng Batik Laweyan continues to exist today [2].

In general, an industry requires the government's assistance in advancing entrepreneurial competence, one of which is the ability to compete. The ability to predict the business climate and deal with these environmental conditions is the competitive ability in question, not the ability to compete with other entrepreneurs. Batik making cannot exist apart from the existence of interconnected innovation and creativity, where creativity is the emergence of new ideas and innovation is their application [9].

The problems confronting the batik industry include pattern plagiarism, the emergence of batik printing, the rapid import of batik into Indonesia, the low interest of the younger generation in the art of batik, and the slow development of the batik industry due to capital and marketing issues, low consumer insight about batik, and the low interest of batik craftsmen and entrepreneurs to innovate [10]. The collaboration and integration of government, academia, and entrepreneurs as Triple Helix actors is expected to assist the Laweyan Batik Entrepreneur Community in creating and forming a space of mutual agreement and extraordinary energy in improving entrepreneurial competence.

As a result, based on the conditions stated above, research into the Triple Helix approach and its suitability in encouraging the improvement of entrepreneurial competence in the Batik Laweyan business sector is required.

### 2 Method

For the purpose of this study, an ethnographic research design was chosen. This study gathered information from three different groups of people: 1) the leader of the Laweyan batik entrepreneur community; 2) academics; 3) businesspeople; and 4) the government. The methods of data collection that were used were primarily interviews, observations, and documentation. In this particular data analysis method, the interactive data analysis technique developed by Miles, Huberman, and Saldana is utilized. This method is carried out in stages, the first of which involves data condensation (also known as data simplification), followed by data presentation, and finally data conclusion.

#### 3 Result and Discussion

The role of entrepreneurship is widely studied as an agent of change in the economic growth of many countries [11]. According to the findings of researcher-conducted research, the laweyan batik entrepreneur community demonstrates strong entrepreneurial skills. This is evident from the presence of several indicators, such as efforts to increase competence that are always carried out by Triple Helix actors to improve skills. The workforce's skill is critical, because written batik has a production process that emphasizes the expertise of batik craftsmen [12].

The Triple Helix actors' harmony and integration has been able to create and form a space of mutual agreement and extraordinary energy in increasing the entrepreneurial competence of the Laweyan batik entrepreneur community. Triple Helix has facilitated the formation of a mutually beneficial collaboration among the three Triple Helix actors involved. Where the government acts as a policymaker, the university as a research development center, and industry as a provider of community service, common goals must be met.

Academics, as Triple Helix actors, review, educate, provide innovation, community service, conduct research, or research on the potential of the batik industry in Kampoeng Batik Laweyan based on the expertise of each academician. Academic research can be used to analyze the potential of the Kampoeng Batik Laweyan cluster to be developed, so that Kampoeng Batik Laweyan can be known by both local and foreign tourists. Academics contribute to the development of tourism by providing solutions and conducting research [13].

Academics have indirectly contributed to the development of the Kampoeng Batik Laweyan tourism sector. The development of the tourism sector has a positive impact because it can improve community welfare, the regional economy, provide employment opportunities for local communities, and even help preserve the local community's culture and local wisdom. Without government intervention, academics' role in developing the tourism sector will almost certainly fail [14].

The government's role as a Triple Helix actor is as a regulator who creates regulations in the form of regulations designed to control a group of people. In order to improve human resources, the government also conducts training (HR). The government has acted as a facilitator by facilitating batik entrepreneurs each year by holding exhibitions where batik entrepreneurs can carry out product titles and market their products in government-facilitated locations. The government plays a dominant role in making regulations, controlling businesses, and directing them [15].

The government's trainings to increase entrepreneurial competence include: 1) natural color batik training, 2) ecoprint training, 3) financial training, e-commerce training, and many more. In this Industry 4.0 era, the industry must keep up with technological developments, and industry players must be able to use digital media as the primary support for their business success [16]. Industries that develop their business through ecommerce can benefit from a variety of business advantages, including increased market share, revenue, innovation, and competitiveness.

Entrepreneurs' role in improving entrepreneurial competence is to constantly develop their potential. An entrepreneur must constantly innovate, including product, process, and marketing innovation. Entrepreneurs help to promote their batik products as well as the potential of Kampoeng Batik Laweyan. This is done as part of an effort to raise the level of expertise of Laweyan batik business owners. Where academics, businesspeople, and the government can connect with one another and collaborate based on their individual capacities and capabilities, it will eventually become a cycle in which each party fills the roles of the other in terms of innovation and creativity. This will allow historical and cultural tourism in Kampoeng Batik Laweyan to become a driver of economic growth in the region.

So far, the government's role in improving entrepreneurial competence has been quite positive, particularly that of Surakarta's Office of Cooperatives, SMEs, and Industry. The government's Bimtek (Technology Guidance) activities have demonstrated that the government should act as a facilitator [18]. These issues can arise because the entrepreneur lacks experience in technical skills, marketing skills, financial capabilities, and interpersonal relationships.




Fig. 1. Pattern for Using the Triple Helix Approach
