#### 1 Review Procedure

The reviews were single-blind review. Each submission was examined by 1 reviewer independently.

The conference submission management system was:

The submitted manuscripts would be checked whether it complies ICLLE author guidelines and template for submission, also whether the manuscript matches the focus and scope. If appropriate, the next process will be carried out. The editor will notify immediately via email.

The manuscripts would be checked with TURNITIN (similarity check). We really concern about plagiarism issues. The manuscripts would be reviewed by an assigned editor to find out whether it contributes sufficiently to the development of knowladge. The manuscripts that qualify at this stage would be proceeded to the review stage by single reviewers.

The manuscript that is accepted with revisions (minor or major), it would contain comments from a reviewer and would be returned to the author for revision. The author is given the time to revise the manuscript no later than one month. The acceptance or rejection of a revised manuscript was final.

# 2 Quality Criteria

Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following dimensions:

- 1. Pertinence of the article's content to the scope and themes of the conference;
- 2. Clear demonstration of originality, novelty, and timeliness of the research;
