

The Role of the Village Consultancy Board in Infrastructure Development in Fursuy Village, Selaru District, Maluku Tenggara Barat Regency

Abstract. The problem in this research is how the role of the Village Consultative Body (BPD) in Infrastructure Development in Fursuy Village, Selaru District The purpose of this study is to describe the role of the Village Consultative Body in Infrastructure Development in Fursuy Village, Selaru District and the Supporting and Inhibiting Factors of the Role of the Village Consultative Body (BPD).) in Infrastructure Development in Fursuy Village, Selaru District. The research method used is descriptive qualitative. Data collection techniques using triangulation, namely observation, interviews, and documentation. Data collection techniques using observation techniques and questionnaires and interviews. Data analysis technique in qualitative research is a data processing process by arranging the data sequence, organizing it into a pattern, categorizing, and describing it. The results showed that the role of the Fursuy Village Consultative Body, Selaru District in carrying out the function of supervising Village Regulations was still not carried out optimally, this was seen from the results of the study found obstacles such as lack of facilities and socialization, as well as technical guidelines that should be given by the Regency Government. The biggest inhibiting factors in the implementation of BPD supervision of the Fursuy Village Government, Selaru District are: Allowances from BPD members, facilities, and understanding of the duties and functions of the BPD in the administration of Village Government, as well as other factors, such as mental attitude, and other factors. existing customs/families. Efforts made by the Village Government to overcome these inhibiting factors include: Regular meetings/consolidation between Village Apparatus and BPD and the community: The Village Head invites sub-district staff/employees to provide knowledge about Legal Drafting; The Village Government always socializes and appeals to the community about the role of the BPD.

1 Introduction

Village or what is called by another name, based on local origins and customs that are recognized and respected in the government system of the Unitary State of the Republic of Indonesia owned to regulate and manage the interests of the community.

For this reason, the Village Consultative Body (BPD) was formed as a legislative institution and a forum that functions to accommodate and channel community aspirations. The Village Consultative Body (BPD) can make a Draft Village Regulation which together with the Village Government is determined to be a Village Regulation. In this case, the BPD as a supervisory agency has an obligation to exercise control over the implementation of village regulations. The Village Consultative Body (BPD) is expected to become a new political forum or arena for villagers and build a democratic tradition, as well as a place for making village public policies as well as being a control tool for the process of administering government and development at the village level. This can be realized if the Village Consultative Body (BPD) as a partner of the Village Head, plays an active role in developing the village together with the village head and the community.

Based on initial observations and information obtained by researchers, development in the village has often been delayed. This can be seen from the still weak performance of the function of the Fursuy Village BPD with other villages in terms of development, such as the lack of supervision carried out by the BPD in the construction of fences, waterways, multi-purpose buildings which until now have not been realized properly. Therefore, the problem in this case is whether the BPD actually carries out its roles in village development in accordance with what has been mutually agreed upon. Village development planning is something very important.

Because it is from this development planning that the direction of village development is determined. Therefore, it is the duty of the village government to accommodate the aspirations of the community in village development planning. Community aspirations can be accommodated by involving the Village Consultative Body in the development planning. Because basically they are the ones who accommodate and channel the aspirations of the community. The Village Consultative Body (BPD) which is a means for the Village Head in Fursuy Village, Selaru District and the community to plan for village development and livelihoods.

The objectives of this research are: To describe the role of the Village Consultative Body in Infrastructure Development in Fursuy Village, Selaru District. And describe the Supporting and Inhibiting Factors of the Role of the Village Consultative Body (BPD) in Infrastructure Development in Fursuy Village, Selaru District.

Research that is relevant to this research is the research of Hidayat and Mesra [1] The results of the research are; forming committees, holding youth meetings, raising funds, finding and buying materials, making goba-goba instruments, establishing goba-goba, socializing to the community, cleaning locations, and reviving or holding goba-goba traditions.

Then also research from Yurni et al. [2] the conclusions of this research are: The role of parents in children's education is very important, not only as breadwinners for male parents and nurturing and caring for female parents, but there are several important things that can be done. Encourage children to be better in their education, namely as parents, they must understand teaching children about socio-cultural, religious, and love life as well as other factors that parents must know. And applied to children. Parents act as educators because in their work not only teach, but also train children's skills, especially training children's mental attitudes.

Then it is relevant to Sumarau [3] The results of this study found that road damage in Makalonsouw village is a problem causes the community to have difficulty in carrying out daily activities - this road infrastructure development really needs to be paid attention to by the local government. This damaged road condition is caused of vehicles that are heavily loaded. Adequate road infrastructure is an indicator that supports economic growth, because with adequate road infrastructure it can facilitate community activities or people who will go out of Makalonsouw village.

Based on the description above, researchers are interested in conducting research on Peran Badan Permusyawaratan Desa dalam Pembangunan Infrastruktur di Desa Fursuy Kecamatan Selaru Kabupaten Maluku Tenggara Barat.

2 Research Method

The research method used is qualitative because qualitative research emphasizes the process of finding meaning, revealing meaning, behind the phenomena that arise in research, with the aim that the problems studied are more comprehensive, in-depth, natural, and as they are. With data collection techniques using triangulation, namely observation, interviews).

Data collection techniques using observation techniques and questionnaires and interviews. The second stage is the advanced stage of data analysis where researchers categorize data or group data into classifications based on data codification that has been carried out in the early stages of data analysis. The third stage is an advanced stage where at this stage the researcher looks for the relationship between the categories that have been made in the previous data analysis stage so that the researcher can then draw a conclusion.

3 Results and Discussion

Based on the data in the field, it shows that the Village Consultative Body (BPD) in terms of involvement in development supervision in Fursuy Village, Selaru District is involved, this can be seen from the participation of the BPD in attending meetings held by the village head. Thus, looking at the four informants' answers, it can be concluded that the duties and functions of the BPD in Fursuy Village, Selaru District, are as representatives of conveying community aspirations to the government, especially in the field of development and the BPD is also tasked with approving, agreeing and supervising all matters relating to village development.

Besides that, the BPD Supervision function in development in Fursuy Village, Selaru District, in the BPD development planning process is involved as a mouthpiece for the community in terms of conveying aspirations and monitoring functions as well as their duties in approving and agreeing on all development planning matters that can be said to be effective.

Based on the research data obtained, it shows that the Village Consultative Body (BPD) as a representative institution in Fursuy Village still has a role in supporting existing development so that it can encourage the smooth implementation of village development. Therefore, the presence of the BPD is expected to function as an institution that has a considerable responsibility in developing the village as well as being a working partner with the village government. In the implementation of village regulations, the Village Consultative Body (BPD) also carries out control or supervision of village regulations.

The discussion in this study is emphasized to determine the role of the Village Consultative Body (BPD) in infrastructure development in Fursuy Village, Selaru District. To see the main points of this research, it can be viewed from the Supervision stage. Supervision can be interpreted as a form of supervising, paying attention to the course of every development process organized by the organization or government.

Irham Fahmi [6] said supervision in general can be defined as a way for an organization to realize effective and efficient performance, and further support the realization of the vision and mission of an organization. can be changed when it is implemented in the field.

In Fursuy Village, Selaru District, the BPD goes directly to the field to oversee the development process to administrative issues, the establishment of control, supervision and good communication between the BPD, the village government and the activity implementation team. Where he is the channel of community aspirations, as well as the number of community complaints regarding development in the village, it can be concluded that the role of the BPD in the supervision stage in Fursuy Village, Selaru District has been running according to the rules and monitoring system for village development well, but one of the inhibiting factors is that Human resources from members are still lacking because the level of knowledge is still below the average because they only reach the level of high school and junior high school education.

BPD as a representative institution in the village has functions and roles that can encourage the smooth implementation of village development. Therefore, the presence of the BPD is expected to function as an institution that has a considerable responsibility in developing the village as well as being a working partner with the village government.

The factors that influence the role of the Village Consultative Body in the process of supervising the implementation of village governance include:

 Mental Attitude: the problem of mental attitude for members of the Village Consultative Body is deemed important to be appointed considering that some members of the Village Consultative Body have a poor mental attitude, this is reflected in personal arrogance who judges negatively/good on the role and function of the Village Consultative Body and always drops the Head Village if it violates various existing provisions.

- 2) Socialization of the Duties and Functions of the Village Consultative Body There are still some members of the Village Consultative Body who do not fully understand what their duties and functions are, therefore this attitude of arrogance arises because of their ignorance of the tasks and functions in question.
- 3) Dependence on Customs/Traditions, bad customs or habits that are still inherited from previous ancestors until now are still carried by some members of the Village Consultative Body, this can be seen from the attitude of feudalism, lack of respect for time, undisciplined still visible in attitude reflected by the members of the Village Consultative Body.

An expert in Sociology of Law, Esmi Warassih, stated that the formation of laws and regulations includes activities related to the substance of regulations, methods of formation as well as processes and procedures for forming regulations. That is, the formation of laws and regulations is not only a juridical activity, but an interdisciplinary activity. Political battles appear in the making of laws and regulations. Laws as legal products are essentially consistency so that the interests and aspirations of all political forces can be accommodated. Considering the law as a political product, it is not always related to the values of justice and morality and is also not always effective in the field because there are various factors that influence it.

In the Filoosofische Theory, Jeremi Bentham in a book entitled "Legal Theory" puts forward the view that the formation of laws and regulations must avoid: double meaning, ambiguity, too broad and inaccurate expressions. In the local context, good governance can be derived into principles of good village governance such as participation, transparency, effectiveness and accountability.

In the process of formulating public policies, including in the preparation of Village Regulations, the existence of community participation is a significant issue. Community participation will affect the pattern of village development policies as the implementation of the concept of democracy. Participation when citizens as individuals as well as social groups and organizations, influence the process of planning, implementing, and also monitoring policies that directly affect to their lives. This means that participation is the principles of good village governance.
