So the camera is an extension of the eye, the text is an extension of the language, the telephone is an extension of the mouth and ears, and so on [3]. If we change the word "medium" to "tool", "tool is an extension of man", then everything is self-evident. All media are essentially tools, they are extensions of some organ of the human being to achieve some purpose.

In 2018, a bus plunged into a river in Wanzhou city, Chongqing, China, causing a sensation across The country. The incident was actually caused by a fight between passengers on the bus and the driver, which caused the bus to malfunction and fall into the river. But the first time the media release pictures of the scene, Internet users saw a red car close to the bus, the car owner was a woman, and someone noticed that this female drivers was wearing high heels, at this moment the comments on the female driver increased with the quickest speed. Critics said the bus plunged into the river due to the female driver's error, and that the bus was forced into the river because the female driver's high heels made the red car impossible to brake. These comments caused the public anger, they thought so many lives are all derived from the operation of the female driver, they then started in Weibo comments against the driver, and even the human flesh searched out the driver's license plate and the driver's home address, so that the irrational behavior caused great influence to the driver, this kind of network violence let women drivers in deep pain. But in the end, the facts appeared, people found that it was not the female driver who caused the occurrence of this incident, and the Weibo comment wave gradually weakened, but the commentators did not think that the impact of these comments on female drivers was a lifelong implication.

User comments on Sina Weibo contain the opinions and attitudes of Weibo users on this topic [3]. In today's society, some major events and emergencies have attracted many people to comment and reply below. In the user comment information, both support praise and oppose to belittle, and some users maintain a neutral attitude towards this event. However, some Microblog users use the Microblog platform to maliciously attack others and spread rumors, which can easily cause bad social influence.

#### 3.2 Case Analysis

McLuhan said, "Media is an extension of human beings", so this paper has also emphasized that human sensory system has changed from a single extension to a multi-sensory extension [9]. People's views on some basic events in the media have changed from seeing and listening to simultaneous mobilization of multiple senses. Such a combination of multiple senses, coupled with the operation and coordination of people's personal brain, makes people have different views on different events. According to McLuhan, we are always inevitably "stepping into" the information transmitted by various media, and we are often immersed in the existence of the media without realizing it. This is the scariest part of media power. People living in the world of the Internet, and people's senses are closely connected to the Internet and some social platform, or even the Internet is an extension of the people and people are used to published his own views on the Internet, so that people are not only benefit from the Internet but also subject to the Internet, this kind of restriction is not completely negative form. These constraints facilitate people's life, and people's ability to master information and digital resources is constantly enhanced, and people's sensory extension and sensory mobilization is gradually diversified. But such a close connection to the Internet has also led to some bad effects. As stated above, people senses completely confined to the environment of the Internet, and people can even feel that as long as they see an event, or see some irrational or even offensive comments about certain events they want to join the ranks. They are likely to go through the computer, and the Internet this tool, let their emotions, their spirit outspread. However, the scene is not the real rationality of form in mind, and the users think that the event development process that they set is consistent, and then begin his own mental and emotional extends through the Internet and social networking platform, but his own comments in the comments section is wanton. Everyone's opinions may only exist as individuals, but all of them together form a very large group that distorts the facts of events, and emotions are used to accelerate the burning of opinions of other net users, leading to the distortion of the real facts of the event, causing people who have nothing to do with the event to become the suspect of the perpetrators, and even causing negative social impact.

## 4 Suggestions

Therefore, although such a comprehensive extension of people's senses drives people's enthusiasm of speech, it will also have a great negative impact. Therefore, the following suggestions can help people to view an event rationally while actively expressing their own opinions to a certain extent, and avoid making comments that are not good for individuals or even the society because of their emotions or interests. First of all, the media or social platforms need to adopt appropriate strategies to restrict the publication of some bad comments. For example, the platform can be monitored in real time, and those comments with great negative emotions can be deleted regularly. Meanwhile, some users who like to post negative comments can be restricted to express their speech. Secondly, the government and administrative departments can introduce some policies or laws and regulations to regulate and restrict the words and deeds of some users, so that users can know that when they are surfing the Internet they also should obey the law, and the bad speech on the Internet will eventually be punished by law. Finally, it is depending on the users themselves. The users need to raise their accomplishment, enhance the ability to see things.
