All of the articles in this proceedings volume have been presented at the ICORT (International Conference on Railway and Transportation) during 6<sup>th</sup> October 2022 in Madiun, East Java, Indonesia. These articles have been peer reviewed by the members of the Scientific Committee and approved by the Editor-in-Chief, who affirms that this document is a truthful description of the conference's review process.

## 1 Review Procedure

All manuscripts submitted to *ICORT (International Conference on Railway and Transportation)* undergo a rigorous screening and review process to ensure that they fit into the journal's scope and are of sufficient academic quality.

Initial screening. A newly submitted manuscript will be screened by the Committee for its conformity to *ICORT* scope and basic submission requirements. Peer-review. If the manuscript passes the initial screening stage, it will be assigned to a handling Committee, who will then send it to at least two experts in the relevant field to undergo a double-blind peer-review. Manuscripts that fail to pass the initial screening will be rejected without further review.

First decision. A decision on a peer-reviewed manuscript will only be made upon the receipt of at least two review reports. In cases where reports differ significantly, the handling Committee will invite an additional reviewer to get a third opinion before deciding. At this stage, a manuscript can either be rejected, asked for revisions (minor or major), accepted as is, or (if significant changes to the language or content are required) recommended for resubmission for a second review process. If it is accepted, the manuscript will be returned to the submitting author for formatting. The final decision to accept the manuscript will be made by the Committee based on the recommendation of the handling Committee team and following approval by the Committee team.

Final decision. At this stage, the revised manuscript will either be accepted or rejected. This decision is dependent on whether the handling Committee finds the manuscript to have been improved to a level worthy of publication. If the author(s) are unable to make the required changes or have done so to a degree below *ICORT* standards (guideline icorte.com), the manuscript will be rejected.

## 2 Quality Criteria

Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following dimensions

- 1. Pertinence of the article's content to the scope and themes of the conference;
- 2. Clear demonstration of originality, novelty, and timeliness of the research;
- 3. Soundness of the methods, analyses, and results;
- 4. Adherence to the ethical standards and codes of conduct relevant to the research field;
- 5. Clarity, cohesion, and accuracy in language and other modes of expression, including figures and tables.

In addition, all of the articles have been checked for textual overlap in an effort to detect possible signs of plagiarism by the publisher.
