All of the articles in this proceedings volume have been presented at the 3rd International Conference on Sustainable Agriculture for Rural Development 2022 (3rd ICSARD 2022) during 23 August 2022 in Purwokerto, Indonesia (Online). These articles have been peer reviewed by the members of the Scientific Committee and approved by the Editor-in-Chief, who affirms that this document is a truthful description of the conference's review process.

1 Review Procedure

The reviews were single-blind. Each submission was examined by 2 reviewer(s) independently.

The conference submission management system was Open Conference System (OCS).

In the first round, the submitted papers were checked their similarity index by using Turnitin to ensure originality. We only accepted papers which Turnitin similarity index was less than 20%. Authors whose papers have similarity index more than 20% were given opportunity to revise their papers.

In the second round, after the initial screening of similarity index, all the Turnitin-passed papers were sent for peer review by matching each paper's topic with the reviewers' expertise, taking into account any competing interests. A paper could only be considered for acceptance if it had received favourable recommendations from the two reviewers.

Authors of a rejected submission were given the opportunity to revise and resubmit after addressing the reviewers' comments. The acceptance or rejection of a revised manuscript was final.

2 Quality Criteria

Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following dimensions:

1. Significance of research
2. Contribution to the field (novelty)
