These articles have been peer reviewed by the members of the *Advances in Economics, Business and Management Research* and approved by the Editor-in-Chief, who affirms that this document is a truthful description of the conference's review process.

## 1 Review Procedure

The reviews were *Double-blind*. Each submission was examined by 3 reviewer(s) independently.

The conference submission management system was Website.

Then, the contributions were evaluated for general suitability and quality. They were sent for peer review after the initial screening by matching the subject matter of each manuscript with the reviewers' areas of expertise while taking into consideration any competing interests. Only papers that had been given favorable reviews by the two reviewers were eligible for approval.

The authors of a rejected submission were given the chance to address the reviewers' suggestions and submit it again. A revised manuscript's acceptance or rejection was final.

## 2 Quality Criteria

Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following dimensions:

1. Pertinence of the article's content to the scope and themes of the conference;
2. Clear demonstration of originality, novelty, and timeliness of the research;
3. Soundness of the methods, analyses, and results;
4. Adherence to the ethical standards and codes of conduct relevant to the research field;
5. Clarity, cohesion, and accuracy in language and other modes of expression, including figures and tables.

In addition, all of the articles have been checked for textual overlap in an effort to detect possible signs of plagiarism by the publisher.
