1 Review Procedure

The reviews were Main editor peer review Each submission was examined by two (2) reviewer(s) independently. The conference submission uses online management system. The submissions were first screened for generic quality and suitableness. After the initial screening, they were sent for peer review by matching each paper's topic with the reviewers' expertise, considering any competing interests. A paper could only be considered for acceptance if it had received favourable recommendations from the two reviewers.

Authors of a rejected submission were given the opportunity to revise and resubmit after addressing the reviewers' comments. The acceptance or rejection of a revised manuscript was final. In further the peer review of the review procedure also undertake for discuss the editorial, material unconscious bias.

2 Quality Criteria

- 1. Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following dimensions Pertinence of the article's content to the scope and themes of the conference focused on the "New Era in Health Care: Challenge, Change and Innovation Technology" with Scope:
 - 1) Medical Technology into Healthcare and Society
 - 2) Innovation and Technology Adoption in Health Care Markets and services
 - 3) Health Care Innovation Contributing Towards a Health governance and Policy
 - 4) Innovation and Technology Development of health promotion media related health risks prevention
