All the articles in this proceedings volume have been presented at the *2nd World Conference on Social and Humanities Research* during *November 20–21, 2022*, in *Makassar, Indonesia*. These articles have been peer reviewed by the members of the *Board of Research and Community Service, Universitas Negeri Makassar* and approved by the Editor-in-Chief, who affirms that this document is a truthful description of the conference's review process.

1 Review Procedure

The reviews were *single-blind*. Two reviewer(s) examined each submission independently. The submissions were first screened for generic quality, suitability, and plagiarism check. They were sent for peer review after the initial screening by matching the subject matter of each paper with the reviewers' areas of expertise while considering any competing interests. Only papers that had been given favorable reviews by the two reviewers were eligible for acceptance. The authors of a rejected submission were given the chance to address the reviewers' comments and submit it again. A revised manuscript's acceptance or rejection was final.

2 Quality Criteria

Reviewers used the following criteria to evaluate the quality of submissions:

1. The article's relevance to the conference's themes and range of topics.
2. The research's originality, freshness, and timeliness must be amply demonstrated.
3. Validity of the techniques, examinations, and findings.
4. Adherence to ethical standards and codes of behavior pertinent to the study field.
5. Clarity, coherence, and accuracy in language and other means of communication, including figures and tables.

In an additional effort by the publisher to spot any indications of plagiarism, all the articles have been examined for textual overlap.
