These articles have been peer reviewed by the members of the *Scientific Committee* and approved by the Editor-in-Chief, who affirms that this document is a truthful description of the conference's review process.

## 1 Review Procedure

The reviews were *double-blind*. Each submission was examined by *at least 2* reviewer(s) independently.

*The conference submission management system was* <https://first.polsri.ac.id/2022/2021/11/03/submission/>.

*Authors submit manuscripts via our online submission platform to the Editorial Office. The Editor-in-Chief first reviews the article; if the manuscript is suitable to the journal's purpose and scope, the Editor-in-Chief assigns a Section Editor to handle the whole review process and return a recommendation or decision to the Editor-in-Chief. The Editor-in-chief selects based on the reviewers' comments and the Section Editor's final decision to: Accept the paper as is with no revisions, Accept after revision, Request that the authors resubmit, or Reject. The reviewers should provide objective, constructive, and expert comments. Detailed comments on article recommendations. One or two sentences are insufficient; at least one paragraph is required.*

*The author is sent an acceptance letter, and the finished work is delivered to production. Occasionally, writers are asked to revise their article in light of the reviewers' remarks and submit the revised version to the Editor-in-chief. Depending on the discipline and type of extra evidence, information, or argument requested, the review period can range from six to eight weeks.*

*After review, the manuscript goes to the 'Copy Editor' who will correct the manuscript in respect of the correct referencing system in accordance with the journal style and layout. When the 'Copy Editor' finishes his/her work, the manuscript will be sent to the 'Layout editor'.*

## 2 Quality Criteria

Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following dimensions:

1. Pertinence of the article's content to the scope and themes of the conference;
2. Clear demonstration of originality, novelty, and timeliness of the research;
3. Soundness of the methods, analyses, and results;
4. Adherence to the ethical standards and codes of conduct relevant to the research field;
5. Clarity, cohesion, and accuracy in language and other modes of expression, including figures and tables.

In addition, all of the articles have been checked for textual overlap in an effort to detect possible signs of plagiarism by the publisher.

*FIRST IC 2022 has a zero-tolerance policy when it comes to plagiarism. As a result, the following policy has been established, which outlines precise steps that will be taken (penalties) if plagiarism is found in an article submitted for publication in FIRST IC 2022.*

*Plagiarism is "the use of the language and thoughts of another author and the presenting of them as one's original work," whether the language and thoughts are used verbatim or closely imitated.*

*According to the policy, all submissions must be unique, never before published, and in no other stage of the publication process.*

*The content that has been taken verbatim from another source needs to be indicated as being different from the present original text by (1) indentation, (2) the use of quotation marks, and (3) identification of the source.*

*Any text of an amount exceeding fair use standards (herein defined as more than two or three sentences or the equivalent thereof) or any graphic material reproduced from another source requires permission from the copyright holder and, if feasible, the original author(s) and also requires identification of the source; e.g., previous publication. Fair use is defined as the amount of text equivalent to more than two or three sentences.*

*Ithenticate will be used to determine how similar each of the submitted papers is to the database.*
