Podcasts are media that include a variety of interesting entertainment content that can be consumed or enjoyed at home or while traveling or while doing something [1]. Currently podcast listeners are increasing in Indonesia, some of them quite enjoy audio services from this new form of media, because the discussions are very diverse on various varied topics that can be chosen according to their favorite genres, such as news, sports talks, mysteries, talk shows, music, comedy, art, entertainment, to everyday experiences or chats from speakers on podcasts. This is what becomes a lesson for those who listen to each of the genres in the podcast from there, making this podcast media an alternative to be listened to by the general public because it is not rigid.

Podcasts have been piloted in a study by Copley [6] which showed that more students download material for study. This means that podcasts are used positively by students. Podcasts make students know an overview of the material to be discussed more easily and quickly so that students are better prepared to discuss the existing material. This makes students have material for discussion of the material to be discussed in lectures, so that students are not empty of material. The use of podcasts in various fields is increasingly widespread, including one in the field of education [7]. This means that the incorporation of technology in education is nothing new. This shows that technology has played a role in teaching and learning. The impact of podcasts on education includes: (1) podcasts can be an innovative teaching resource for teachers to design classroom activities. (2)

podcasts help student learning processes, both inside and outside the classroom, (3) podcasts can improve the readiness and preparation of prospective teachers (Goldman, 2018). This means that it is the same with power points and class videos or others, that podcasts can be used as digital-based learning.

Frydenberg and Nathan & Chan [8] test that the purpose behind using podcasts can be divided into 3 categories, namely: increasing flexibility in learning, increasing learning accessibility (especially in relation to the use of mobile access), and enriching student learning experiences (especially on campus subjects using blended learning experiences). This shows that flexibility is important in learning supported by access so that it will enrich students in terms of experience. On the other hand, the very significant growth of podcasts over the last few years is influenced by 5 main factors [9], namely internet activity that continues to spread, broadband growth is accelerating, the difference between streaming and downloaded content is getting blurry, computer availability widespread personal and multimedia devices, the adoption of portable mp3 playback devices is so fast. The internet and science and technology which are vital roles are then followed by the following factors, so that podcasts can become useful learning media in terms of innovative learning processes.

Based on the results of questionnaires made by researchers and then distributed to informants online, there are a total of 400 informants, in this case the informants are students of Lampung University class 2020. Overall, Lampung University students' batch 2020 have heard the word podcast, know what a podcast is, listen to podcast content, listen to podcasts regularly, get a lot of knowledge or information from listening to podcasts, listen to podcasts either alone or with friends, and know what is called a podcast. Master of audio story telling. This shows that the use of podcasts supports innovative learning. Learning is essentially a process of interaction between students and their environment, which previously could not be able to make students change their behavior for the better [10]. Meanwhile, according to Corey [11] Learning is a process in which a person's environment is deliberately managed to allow him to participate in certain behaviors under special conditions or produce responses to certain situations. The combination of 3 dimensions in education, namely assessing, teaching, and learning, not only enables students to gain learning experiences but to continue to maintain learning opportunities both in the classroom and outside the classroom. According to Shimp, Shropsire, Park, Harris & Campbell [12] suggest that podcasting should be used to complement class material so that students can better understand concepts, theories and applications that may not be available during class. This point indicates that instruction in exploring learning through podcasts by completing class material so that students when viewing or listening to podcasts can understand the concepts and theories. Podcasts allow for spatial and temporal flexibility by providing control for listeners to listen to files anywhere and anytime [12]. This indicates that the implementation of students in exploring learning through podcasts can be done with unlimited time, because with podcasts students can listen and see what has been downloaded or view online anywhere and anytime, thus allowing students to learn to be flexible. Thus, educational materials can be offered independently according to the time and place of the listener [13].

Students' collaboration in exploring learning through podcasts can be seen from Piñeiro-Otero [14] and Borges [15] which examine the benefits of using podcasts for student learning in which there is an element of collaboration itself. We can observe this collaboration in the following points: First, there are cognitive advantages, where the use of podcasts can increase students' competence in communication and personal relationships, collaborative learning and interpretation, analysis and content selection and distribution. This means that students' collaboration skills in terms of personal relationships, communication, and analysis can be improved by exploring learning through podcasts. Second, student involvement, namely the use of podcasts can encourage independent learning. This indicates that collaboration is for independence from one individual to another by exploring learning through podcasts. Then third, student-self management, where students must plan their work considering the asynchronous nature of podcasts. The important point in this case is the ability of students to collaborate in planning lessons through podcasts. Fourth, access to teacher directions, where educators can provide the necessary guidelines or directions so that students can listen to class material anytime and anywhere. This means that educators and students must communicate with each other in order to provide direction through podcast learning. Fifth, continuity of study, podcasts can improve students' ability to manage and utilize podcast content on a regular basis. This shows that students' abilities in collaborating abilities and utilizing content. Sixth is comprehension, given the possibility of repetition, podcasts facilitate understanding of certain content while strengthening learning. Student collaboration through podcast learning by strengthening learning understanding by repetition in podcast content. Seventh, anxiety reduction, podcasts can reduce students' anxiety about certain subject content or at the time of evaluation because students can review the content at any time. Indicates that students can access podcasts according to their own abilities and are not fixated on the situation.

#### 6 Discussion

In essence, in the learning process, of course before implementing it there must be preparations made both from the educators themselves and the students themselves. The preparations carried out indicate that to develop competence for both parties. Teaching preparation reflects what educators will do to make learning easier for students, how to do it and why educators do it. This means that between educators and students there has been previous communication and avoid miss communication in the implementation in the field later. Teaching preparation has an essential position in effective learning because it will help create good work discipline, a more interesting atmosphere, and wellorganized, relevant, and accurate learning [16]. The main thing that needs to be considered in the selection of discussion topics is that the topics discussed must be problematic. This means that the topic raised has a problem power that can be analyzed from various points of view, so that it does not only benefit one party when the topic is raised in the learning process, then at the end there are constructive conclusions from the results of the discussions carried out.

The selection of discussion topics must refer to several things concerning the students themselves, including: 1. Stimulating students to be actively involved in scientific debates, indicating that the discussion topics turn on the scientific atmosphere between one student and another. 2. Train students to think critically and openly, meaning that through the specified topic, the students themselves can produce strong and sharp thinking power. 3. Developing a democratic atmosphere and training students with big hearts, this indicates that when students share their opinions, other students must respect and accept them without dropping the individual dignity and worth of students. 4. Students have different views about the problem that is the topic of the discussion, meaning that the topic raised has multiple interpretations. 5. Students have knowledge and opinions about the problem to be discussed, indicating that previously students have searched for and mastered the chosen topic. 6. The problems discussed are related to other issues as well, this means that the topics raised intersect with other disciplines and can be connected scientifically [17].

The discussion topics chosen must also be able to develop attitudes towards controversial issues, so that individual students with the selection of topics to be chosen later, when it has been determined must be able to have an attitude towards the topic of discussion even though we are in a position where we think we are not. Agree with a topic that is very controversial in the community, for example: there is a case regarding the increase in fuel prices, then the topic becomes controversial for the community, some agree and some disagree. When the topic is used as a discussion material, we must be able to have

a view from the point of view of agreeing and disagreeing. This is in line with: 1. Train students to develop the skills of asking, communicating, interpreting, and concluding the discussion, in this case the fighting power in thinking is present in individual students. 2. Train and establish social-emotional stability, indicating that they are ready to be in a pro or con position. 3. Develop the thinking ability of each student in solving problems, to be able to develop a more positive self-concept. 4. Develop the success of students in finding and expressing opinions. 5. Train students to dare to have an opinion about a problem, not afraid if they agree or disagree on the topic to be discussed [17].

There are several things that need to be considered in choosing the main topic in the discussion activity, including the following: 1. The main issues or cases to be discussed must be clear, meaning that the issues to be raised should not be abstract or ambiguous. 2. The basic concepts for reference to problem solving in the discussion have been understood by students, meaning that in choosing the topic, participants already know how to solve the problem. 3. The role of educators is to guide discussions, not give lectures, for example, this guides shy students to be active and control students who talk too much. Meanwhile, even in its implementation, the discussion has several characteristics, including: a. Understanding of the problem, meaning that students understand the issues discussed and have material. b. Learning together, indicates that the discussion carried out has a strong power to learn from one another. c. Understanding other people's opinions, meaning that we as students must understand what other people's opinions mean. d. The formation of a sense of solidarity, meaning that after we finish the discussion there is no dispute with what was conveyed during the discussion. e. Understanding of decision making, indicates that decisions are made based on what was conveyed during the discussion. f. Applying the problem solving method, means that all the problems raised we try to have a solution given. g. Applying ways of expressing opinions, from here students learn a lot to express opinions in accordance with the rules of politeness [18].

Not infrequently, in the selection of discussion topics, there are several limitations that need to be considered, including the following: 1. It is difficult to determine problems that are in accordance with the level of thinking of students and have relevance to the environment, meaning that between one student and other students of course have different levels of thinking on the problem that is used as a topic can be better or vice versa. 2. The discussion or problem often expands and expands, indicating that the topics discussed are often out of the way of the existing discussion. 3. Relatively takes a lot of time, the process is not short but long. 4. Differences of opinion can invite reactions outside the classroom and can even lead to physical clashes, sometimes students who are still not satisfied bring problems out of the classroom. 5. Dominated by certain people who are usually active, active people show their existence and become an arena for them, while people who are shy but have more thinking power sometimes suppress it and this must be the task of educators when in the field.

Based on the data obtained by the researcher, it can be concluded that the Lampung University students class of 2020 have certain themes when listening to podcasts, the percentage figure is 85.6%. Meanwhile, there are several themes that are preferred by Lampung university students when listening to or watching podcasts, including social culture with 23.2%, followed by food and fashion 11.6%, and continued with education

7.3%, the rest the theme is government., religion, technology, economics, and comedy. The connection in terms of choosing the main topic of discussion in learning based on podcast program variants is adjusted to the interests of the students themselves and adapted to several things that have been explained in the writing above. Broadly speaking, each individual student has a theme that he likes and has abilities based on what the students choose themselves. Learning based on podcast program variants makes it easy for students themselves, because students can search for topics according to their personal desires and there are many channels that provide themes according to the wishes of students. It's just how the students themselves respond to things that need to be considered in discussions through podcast programs so that they are not taken for granted.

## 7 Conclusion

Learning through podcasts not only increases general knowledge about what is discussed on podcast shows, but podcasts can improve listening skills for students themselves.
