

# Difficulties in Implementing Teaching for Educators of Government Officers with Work Agreements

**Abstract.** This study set out to uncover the issues and challenges that working educator with work agreements faced. Quantitative research techniques gathering data on Palembang City's Educators United with Government Employees with Employment Agreements. The research sample in Palembang City consisted of 38 educators who had work agreements with government employees. Data were gathered using survey and documentation techniques. Government employees with employment agreements are obliged to complete a questionnaire with 48 questions from 6 indicators: teaching preparation, teaching process, teaching facilities and media, teaching strategies, teaching assessment, and remedial in teaching. The study's findings revealed that they had no issues and that they were government workers with work contracts that they had to uphold.

#### 1 Introduction

Both government officials and independent contractors who work as educators must be able to overcome various learning difficulties and obstacles. Or, to put it another way, PPPK is a non-permanent worker. Additionally, a citizen of Indonesia who satisfies the conditions of ASN's definition of PPPK is appointed based on a work agreement for a specific period of time in order to perform official tasks [10].

Furthermore, according to [11] a functional official's (JFT) primary responsibility is to provide public services, and PPPK is the invention of fresh concepts and bureaucratic innovation. Additionally, as per [12] The ASN Law requires PPPK, a professional employee with shown competence, in order to advance ASN professionalism in the management of government affairs.

The main point of his study is that educators from diverse domains of expertise cannot equally cover what is taught by educators due to the limitations and challenges described. Education, financial systems, information systems, how to educate, analyze, and overcome education are the six dimensions of perceived hurdles and challenges. High School and Vocational High School are present in the city of Palembang, which is the focus of the study. Whether or whether the present education system in Indonesia is effective will be greatly impacted by the different issues listed above. The process of removing barriers entails several processes, including those for error avoidance, clarification, explanation, and correction [14]. Students are expected to be able to catch up due of these challenges so that the teacher can choose the appropriate learning technique [16]. Then based on [17] Barriers are situations that could prevent implementation from proceeding smoothly and without interruption. According to [20] educators' reactions to implementation difficulties. To guarantee that policies are accepted and carried out as intended, adjust policies to meet these demands in schools and incorporate local educators as equal partners in crafting policies. Teachers may feel more inspired to establish classroom policies if they are involved and ensure that basic requirements are satisfied initially.

The problem as it is defined by the research is how a government employee with a work agreement is able to overcome obstacles and challenges when performing their obligations as a teacher. The purpose of the study is to determine the challenges and obstacles that educators who are government employees with work agreements encounter when carrying out their responsibilities as teachers or educators. Based on the methodology used for data analysis, the percentage of [32] Researchers Using Value Intervals 10% - 50% = Medium, 50% - 75% = High, and 75% - 100% = Very High. 0% - 25% = Low.

### 3 Results and Discussion

In the city of Palembang, this study was done in 13 schools, 13 of which were high schools or vocational high schools. 38 educators who are employed by the government and have work agreements were given the research sample. Documentation and questionnaire methods are employed to obtain data. A questionnaire with 48 questions was sent to educators who are members of Government Employees Unity with the Work Agreement. In this study, numerous students and the researchers themselves visited Government Employees Unity Educators with Employment Agreements to ask them to complete a questionnaire. The questionnaire was gathered for one month, from August 13 to September 13 2022.

Based on the answers to a survey of 38 educators who were government employees with work agreements, this questionnaire had 48 questions. The questionnaire, which was designed with 48 questions and alternate responses pertaining to 38 Pendidik Bersatus Government Employees with Work Permits, was not validated or rehabilitated as a result of this. Preparation scored 84.21% (high category), Process scored 88.16% (very high category), Facilities and Media scored 75, 66% (very high category), Method scored 84, 21%, Evaluation scored 84.21%, and Remedial scored 81, 58% (very high category). The findings of the six indicators related to teaching preparation, teaching process, teaching facilities and media, teaching techniques, teaching evaluation, and teaching remedial are as follows (Table 1).

Based on the responses of 38 respondents to questions about teaching preparation, it was reported that there were no difficulties, by 21 respondents with a percentage of 55.26%, that it was quite difficult, by 10 respondents with a percentage of 19.74%, that it was difficult, by 7 respondents with a percentage of 9.21 percent, and that there were no very difficult responses. As a result, the average respondent's response for teaching preparation questions was 84.21%.

According to the findings of the study, [33] According to the teacher, just 47.14% of students need to be prepared for class, while the remaining 52.86% believe that preparation is not as important as it should be. As a result, the average respondent's response for teaching preparation statements was 88.16%.

This is consistent with the findings of the study [35] demonstrates how teachers' understanding of the teaching and learning processes used in the classroom has an impact on how motivated students are to learn.
