This 20-minute video was edited twice with Chen Kaige's film "The Promise" as the material, and adopted the program style of "Legal Scene" to make an ironic interpretation of "The Promise" through demolition and reconstruction. The appearance of the short film quickly occupied the headlines of major forums and video websites. Later, the birth of a large number of digital products expanded the scope of video, and many film lovers began to learn drama, editing and directing, providing more excellent works for the Internet. At the same time, the TV platform also collects excellent short films for broadcast. In addition, China has established two of the most authoritative short film festivals: the China New Media Short Film Festival "Jinpeng Award" and the nine-minute original film championship, attracting a large number of short film lovers to participate in it. #### 1.2 Classification of short films

Short film consists of film short film, animated short film, documentary short film and short video.

**Short films.** The short film takes the plot as the carrier to convey the theme of the film. Short stories are obviously different from commercial ads or short stories. It needs to tell the story content and convey thought and emotion based on certain facts or fictional plots. Most popular "micro films" are shot in the form of short stories. Short stories can be divided into thrillers, drama, philosophy, family and other types.

According to the production method, the animation short film can be divided into four types: plane hand drawing, virtual generation, three-dimensional shooting and real life combination. According to the media, it is divided into four types: television, cinema, advertising, science and education. According to its nature, it is divided into commercial and experimental types.

With the characteristics of a wide range of audiences, the development of animated short films in the world began relatively late. Animated short films were introduced into China in the mid-1920s, starting with the 12-minute animated short film "The Studio" shot by the Wan Brothers in 1926. Since then, the Wan brothers have made many excellent animated short films with social impact, such as "A Letter Sent Back", "Dog Detective" and "Camel Dance". In 1956, under the guidance of the "Double Hundred Policy", China's animated short films opened the road of construction and entered a period of rapid development. After 1990, the output of animated short films in China continued to increase. Until the new era, China's animation short films continued to innovate and develop, and a large number of influential animation short films have emerged.

**Short documentary.** The documentary short film takes real people, reality and real situations as creative materials, and shows the corresponding real nature through artistic processing, with the main purpose of guiding people to carry out in-depth thinking. Documentary short films are classified in the same way as traditional documentary films, including life, culture, thematic, biographical and other types.

In the era of new media, audiences accept a lot of fragmented information, and have limited input into documentaries with longer lengths and more complex plots. In this case, short documentaries have emerged in response to the development of The Times. Documentary short films, like documentary films, emphasize "authenticity." Based on recording people's real life, it carries out certain artistic processes and presents fragments of social life. The shooting time and cost of documentary films are much lower than that of traditional documentaries, and the length and splicing of documentary films are free, and they start straight to the content point, and do not strictly follow the narrative logic of traditional documentaries, so they can adapt to the needs of current audiences.<sup>1</sup>

**Short video.** Short video comes with the development of Internet technology. With network communication as the main medium, the length of video is mostly within five minutes. With the development of the Internet celebrity economy, the content of short videos includes a variety of topics such as skill sharing, fashion trends, street interviews, advertising creativity, and life records. Short films are very different from microfilms. It does not require a specific team or superb skills. It can be achieved by using mobile phones, SLR cameras and other equipment with recording function.

In the information age and network age, short videos have been widely distributed on the vast new platform, and have won a large number of fans, capital and network platform favor. Tiktok, Kuaishou and Toutiao joined the short video industry. Until 2017, the development and competition of the short video industry has entered a near-white-hot state, and the content, creative methods and artistic expression forms of short video have gradually shifted to professional operation. The national public information network security supervision department has continuously increased the management and standardization of the network platform, and strengthened the cleaning and control of bad information. Zhang Shichuan, Zheng Zhengqiu shot the short story "Labor Love", and created a star film company. The main reason is to compete with foreign film companies. During the Anti-Japanese War, animated short films added a lot of "fighting" elements, but also an attempt to awaken the enthusiasm of the Chinese people. The short film has a good effect on the continuous national culture. For example, the "Chinese School" adds unique Chinese New Year pictures, puppets, shadow puppets, ceramics and other modeling elements, and traditional Chinese culture jumps confidently onto the screen and promotes the development of other short films. Chinese short films have always been rooted in the reality of the country, making the content of the film equal to the acceptance of the group. Subsequent short film directors have also made efforts to practice cultural consciousness and have achieved good results.

### 2.2 A boost for feature length operation

Short films are short in form, and their discourse form, narrative mode, content expression and operation mode are easier to explore, and it is easier to promote the development of long films. Almost all early films began with short films, and it was because of the exploration of "Difficult Husband and Wife" and "Black Soul", that later feature-length films have diversified styles. The star company also started with a funny short film and gradually developed into a Wuxia feature film, which is a reflection of the short film's continuous attempts. In addition, the production and distribution of short films also has an important impact on feature-length films. Short films are marketed by

MicroBlog, Little Red Book, Tiktok, etc., which have certain references for the publicity methods of feature-length films.

# 3 The role of short films in the history of world cinema and television

### 3.1 Short film and the art world jointly support the contemporary world of film and television art

"The world of film and television art creates standards, not the other way around." As Adorno said, "Art needs to adapt to the technical standards of its time, or it will regress."

The opportunities for artists to display their work are no longer limited to the venue: first, multimedia landscapes are installed in the exhibition venue, and short films of relevant contemporary artworks are repeatedly played. The second is the excessive media of the creation process, and the creation plan extends to the public art space indefinitely. For example, Shao Yan's on-site creation in squares and parks is reproduced as video on new media platforms such as Tiktok. In the 1960s and 1970s, "land art" originated in the United Kingdom and the United States, expanded its artistic influence

through the materials and locations used, and became popular all over the world, of which the short film contributed greatly.

# 4 Analysis of the value of short films in the history of film and television in the world

### 4.1 To develop an understanding of the world of film and television art

From the moment the image appears, people's understanding of the world is almost based on the image, and they are used to understanding things and observing life through the image. ### 4.3 Bridging the gap between art and the public

The short film breaks the limitation of the film's imagination with its unique inclusiveness, from the traditional set of narrative aesthetics to the free and diversified image experiment. More and more short films can express the reality of life in a multi-faceted society and complex human nature, and gradually focus on realism aesthetics with individuals as the center. In addition, information exists in a huge network, and the public can enter the information flow at any time and anywhere. It is precisely because of the non-hierarchical, non-linear and decentralized characteristics of short films that the dominance of feature-length films in the history of film and television in the world has been broken, so that the public can participate in the creation and interaction of art at any time.

### 5 Conclusion

In today's new era, with the progress and development of advanced technology such as information technology, network technology and digital technology, various ways have been provided for the dissemination of short films, making short films and television

have broad prospects for development with its low production cost, rich forms of expression and outstanding innovation.

But at the same time, because of the short creation cycle and low cost, more and more people tend to show their personal work and life. In this way, the boundary between private space and public space is gradually blurred.
