# The Role of the School Committee in Improving the Quality of Education At SD Negeri Kauman Kapanewon Pleret

#### ABSTRACT

This study explores the role of the school committee in improving the quality of education at SD Negeri Kauman Kapanewon Pleret. This research aims to obtain an overview of the role of the school committee in improving the quality of school education, namely as a consideration provider, as a supporter, as a controller, and as a mediator. This study uses qualitative research, data and information are collected and studied by means of observation, interviews, and documentation. Research subjects include school committees, principals, teachers, and student guardians. Meanwhile, the object of the research is the role of school committees in improving the quality of education which is studied from four aspects of consideration, supporting, controlling and mediator. The data analysis used is data reduction, data presentation and conclusions. The results of this research show (1) As an Advisory Agency, the School Committee at Kauman State Elementary School has prepared policies and programs related to RAPBS, education management processes and procurement of educational resources (educators, teaching staff, facilities and infrastructure, budget ). (2). As a supporting agency (Supporting Agency), it manages community donations which are used for school renovations, purchasing drumband equipment, scholarship funds for underprivileged and high achieving students. (3) As a controlling agency, it provides input and control over RAPBS planning, supervises the conditions of teaching staff and students, monitors the economic conditions of student parents. (4) As a Mediator (Mediator Agency) this can be carried out well, because the people selected as School Committee administrators are those who are considered community figures. So the existence of a School Committee represented by people active in the community is an appropriate means of liaison between the school and parents or the community.

#### **1. INTRODUCTION**

The role of the school committee is urgently needed to reduce dependence on the government which intervenes in policies and programs in schools [13]. If the school is intervened, it cannot develop a program independently, especially in improving the quality of education [14].

## 2. THEORETICAL STUDY

#### 2.1. Education Quality

Budget allocation to run school programs and monitor school participation in school programs.

## **5. CONCLUSION**

Based on the discussion above, it was concluded that regarding the role of the committee as an advisory body in carrying out the role as giving consideration, the School Committee at SD Negeri Kauman, Kapanewon Pleret has provided input and prepared policies and programs related to the RAPBS. Monitor the condition of the school education budget, and evaluate the implementation of school budget support. This is evidenced by the management of education and the procurement of educational resources (educators, teaching staff, facilities and infrastructure, budget). The role of the School Committee as a school supporter is to achieve school goals and improve the quality of education. The support provided by the School Committee already exists in the form of material in the form of school facilities. The School Committee also provides support for the conditions of teaching and noneducational staff, with proof of the recruitment of dedicated teachers and the provision of additional honorariums every month. Apart from that, the support provided also takes the form of monitoring the condition of existing facilities and infrastructure at the school. The School Committee can monitor the condition of the school directly or receive input from the community, after which the School Committee follows up on these findings by making a renovation program, constructing buildings and providing school facilities every year.

The School Committee as a controller in schools is quite good, such as providing input and control over decision making, participating in planning the RAPBS, controlling the use of the budget and its allocation, monitoring the implementation and participation of school stakeholders in school activities or programs and monitoring learning processes/outcomes. Meeting activities are usually used to evaluate the implementation of school activities and use of the budget. The School Committee also receives suggestions and criticism from the community about the school, then the School Committee will deliberate and mediate regarding these findings. The School Committee also plays a role in monitoring the conditions of teaching staff and students. Such as controlling the quality of honorary teachers in budget matters, namely the use of funds from the School Committee and BOS. The School Committee monitors the economic condition of parents of students who cannot afford it, then provides a solution for providing scholarships. Accompanying and provide scholarships to students who excel in competition activities. As a mediator between the school and the community, it can make it easier for the community to channel their aspirations, and make these aspirations into input for the school as policies and programs. That the role of the School Committee as a mediator or liaison can be carried out well, because the people selected as School Committee administrators are those who are considered community leaders so that they have many opportunities to meet with the community outside the school, even though not in formal meetings at school.
