# 2. QUALITY CRITERIA

Reviewers were instructed to assess the quality of submissions solely based on the academic merit of their content along the following dimensions:

- The article's content must relevant and suit to the scope and themes of the conference;
- 2. Clear demonstration of originality, novelty, and timeliness of the research;
- 3. Soundness of the methods, analyses, and results.
- Adherence to the ethical standards and codes of conduct relevant to the research field.
- Clarity, cohesion, and accuracy in language and other modes of expression, including figures and tables.
- 6. Follow the author guidelines of the proceeding.

All submitted articles have been checked for plagiarism through Turn it in application. The maximum limit of similarity is 25%. if the similarity content is more than 25% then the article is returned back to the author to revise the article to reduce the similarity content.
