The other is the student to obtain employment have distinction and certificate test, not enough emphasis on practice teaching. Results of the practice teaching of ideological and political theory is not easy to quantify, the effect is recessive, lead to funds into the thought politics theory class practice teaching to a large extent limited. In driven by pushing the idea influence, put a lot of money on the theoretical teaching on the teaching effect is easy to quantify, and funds input to the thought politics theory class practice teaching are few and far between. As a result, make a lot of thought politics theory class practice teaching activity dropped because of funding problems, or in the practice of ideological and political theory teaching has not been carried out, because the funds shortage, simply cancel some practical teaching arrangement. And on the base construction also has many problems, some colleges and universities is not a stable off-campus practice teaching base, some colleges and universities is the bottom of the redundant construction level of off-campus practice teaching base, some colleges and universities is to build a long-term off-campus practice bases is not reasonable use of practice teaching base. Many colleges and universities campus practice teaching platform has not been established.

# Strengthen the Ideological and Political Theory Class Practice Teaching Effectiveness of Countermeasures

Based on the existing problems in ideological and political theory course teaching practice, and an objective analysis of the causes of these problems, the author tries to put forward from the following several aspects to improve practical teaching effectiveness of the countermeasures and Suggestions.

**Improve the Understanding of The Practice Teaching of Ideological and Political Theory.** To know is the forerunner of action, the practice teaching of ideological and political theory of efficient to carry out smoothly depends on school leaders, teachers, students, parents and society can correctly set up the education idea of "practice".

First of all, we must strengthen the school leaders at all levels to study the theory of ideological and political theory class teaching practice, the practice teaching of ideological and political theory,
