Because the red cultural relics project can obtain economic benefits through the red tourism, so the formation of a number of departments for the right to management, bull management, each department acting on its own phenomenon; some red cultural relics due to remoteness, difficult exploitation, heritage protection appears blank area, a lot of valuable heritage was destroyed, abandoned, almost deserted. In the red cultural heritage protection, has not yet set up a strict tracking system. We do not give the relevant administrative personnel should not be given a blow. We are not enough to trace the administrative staff misconduct and punishment. The lack of public awareness of the place of red cultural relics, public participation is an important condition for the protection of red cultural relics, but now most of the red cultural relics of the public generally indifferent attitude. They believe that the act of protection should be the responsibility of the government departments have nothing to do with their own, lack of awareness of ownership. At the same time, developers and operators lack of awareness of legal protection. Developers and operators in the process of red tourism in order to maximize profits, it is necessary to attract as many tourists as well as the construction and a large number of tourist facilities. This will cause irreversible damage to red artifacts.

4. Current situation of legal protection of red cultural relics

4.1Establish legal system

Red cultural relics in our country are rich and widely distributed. Each region has its own characteristics in terms of the number, distribution and type of heritage, and reflects the diversity of regional culture. According to the different types and different natural and social environment of the red cultural relics, the various regions of the heritage management methods should be different, the relationship between the whole culture highlighting regional characteristics and heritage and area. These should be reflected in the local protection laws and regulations. At present, the provincial and local regulations, is formulated in accordance with the relevant national heritage regulations, the object is not from the provisions of the national heritage act and category, obviously insufficient reflected in the regional red cultural relics special aspects. The region has a wide range of independent legislative rights. At the same time, the current administrative regulations laws and regulations related to red cultural relic's management regions as soon as possible. While strengthening local legislation, the state should speed up special legislation. The provisions of this kind of law can be discussed from the characteristics of the type of red cultural relics, management priorities and difficulties, and puts forward specific management measures and the corresponding rewards and punishments measures to make the law more targeted and operable. In view of the different ways of the local legislation to manage the administrative divisions of the heritage, the special legislation is mainly reflected in the historical characteristics of the red relics and the development of respect for the context. It is necessary to take into account the differences in economic



and cultural environment in different regions, more importantly, to give full recognition of the comprehensive value of various types of red cultural relics. The law should be clearly defined for the protection of content, the protection of operating procedures, the protection of institutional functions, the protection of funding sources, etc., so as to effectively protect the requirements of red cultural relics.

4.2 Strengthen law enforcement

If there is a strong red heritage law enforcement supervision team, even with the red cultural relics protection law again perfect in vain so to make the red cultural relics preservation law can be implemented smoothly, the red relics are not violated, strengthen the construction of the red cultural heritage law enforcement supervision team is very necessary. According to the actual situation of different regions, different ways to carry out the construction of red cultural heritage law enforcement supervision team. The central government can guide and supervise the protection of red cultural relics in China through the establishment of the Ministry of cultural relic's protection. In local areas can be combined with local police, law enforcement agencies, such as the establishment of comprehensive law enforcement agencies to improve the law enforcement. Additional market supervision team or to report illegal phone calls around the red cultural relics market, strengthen the red cultural relic's market inspection work, enhance the vigilance of people on the red relic's crime, so that criminals can take advantage of the machine. At present, the red cultural heritage administration law enforcement departments according to the existing law, changing the concept of law enforcement, management system and mechanism innovation, the establishment of the administrative law enforcement supervision system, the implementation of the judicial protection system of administrative law enforcement responsibility system, perfect and effective, the establishment of red cultural heritage protection of the public interest litigation system. At the same time, we can also select the outstanding personnel in the public security criminal investigation team to organize a special red heritage law enforcement team, responsible for the fight against a series of red cultural relics and criminal activities. It can effectively reduce the production and smuggling and other illegal and criminal activities of the red cultural relics.

4.3 Improve legal consciousness

The job of cultural relics protection, not only rely on the competent authorities of business. This requires the power of the whole society. Therefore, it is necessary to enhance the awareness of cultural heritage protection and the legal concept of heritage conservation. Legal protection of cultural relics cannot be separated from the role of the media. Through the dissemination of media functions, it can expand the influence of cultural relic's protection awareness. In addition to news reports, can be produced around the local history of the development of the context, the promotion of major archaeological discoveries and cultural relic's protection of the results of the program. Strengthening publicity and education is

an important way to consolidate and improve the protection of red cultural heritage. To increase the content and provisions of the protection of the red cultural heritage in the law, strengthen the propaganda of the red cultural heritage protection. Through publicity and education, the popularization of laws and regulations related to the red cultural heritage and scientific and technological knowledge.
