In addition, on the basis of conscientiously carrying out the relevant policies and regulations of the state, the Yunnan provincial government has made significant achievements in the regulation and investigation of some illegal and illegal operations in the tourism market.

Yunnan province has also launched the "Internet + tourism" industrial model, built a large tourism data center and the corresponding tourism network trading platform, greatly promoting the modernization of the tourism industry. In the aspect of standardizing the tourism market, Yunnan province has also made active efforts and exploration. On the one hand, Yunnan Province set up a special tourist police force, set up a special management organization, responsible for the maintenance of the tourism market order, and investigate and deal with all kinds of illegal and illegal behavior. At the same time, Yunnan actively promotes the construction of corresponding tourist market command centers in various cities, and plans to carry out various tourism industry guidance work as a whole. In addition to the achievements of the system, Yunnan has also planned a series of key tourism projects, such as opening to the outside world, quality improvement projects, and urban and rural environmental construction projects, to improve and optimize the tourism environment and improve the tourist experience.

#### 3. Analysis of the Impact of Tourism Industry Regulation on Economic Growth

The impact of tourism industry regulation on economic growth can be described by quantitative relationship.
