D. Lack of teaching research

However, in view of the current situation of physical education teaching in Colleges and universities in China, there are fewer teaching and research topics for physical education teachers. In this situation, most physical education teachers will rarely have the opportunity to participate in teaching and research, especially young physical education teachers, which directly hinders the individual physical education teachers' improvement of ability and quality.

IV. Measures to Strengthen the Construction of Physical Education Teachers in Colleges and Universities

A. Strengthen training and continuing education

In the process of development, colleges and universities must actively create training and continuing education opportunities for physical education teachers, regularly summarize the problems existing in the teaching process of physical education teachers through the construction of learning platforms, and then carry out targeted training on the platforms, so that teachers can realize continuing education and truly build a higher quality and level of teachers [3]. In order to further ensure the effectiveness of the construction of physical education teachers in Colleges and universities, in the process of training and educating teachers, schools can carry out different levels of training for different levels of teachers. In addition, in order to effectively retain high-quality and high-level sports teachers, the school also needs to improve the performance appraisal system, combining with the actual situation of the school to formulate the work test of physical education teachers. At the same time, we should improve the post-performance appraisal system of physical education teachers, so as to form a more perfect and sounder appraisal system of physical education teachers, provide better development prospects for physical education teachers through effective appraisal and evaluation mechanism, and encourage physical education teachers to participate in physical education more actively. In the process of assessment, schools can link the results of assessment with teachers' rewards and punishments, appointment and promotion. For those teachers whose assessment fails to meet the standards, they need to be allowed to study on the job. For those teachers who are not qualified, they need to implement the transfer of posts. Through this measure, a high-quality and high-level team of physical education teachers can be truly built

C. Strengthen the Construction of teachers' Morality

In the process of the construction of P. E. teachers in Colleges and universities, it is necessary to strengthen the construction of teachers' morality so that teachers can really establish a good image of educating people. Therefore, in the process of the construction of physical education teachers in Colleges and universities, the school must strengthen the cultivation of professional ethics of physical education teachers. Firstly, the education of devotion to work and love for students should be carried out among teachers. The main purpose is to strengthen the propaganda of excellent physical education teachers' deeds by school sports leaders. Through this measure, teachers' sense of ownership and responsibility of professional ethics should be stimulated so as to enable them to work in the process. In order to build a good teacher-student relationship, we should cultivate the teaching thought of "being willing to be a ladder". Secondly, when strengthening the construction of physical education teachers in Colleges and universities, the school also needs to build a relatively perfect system of teachers' ethics, and clarify the duties and requirements of teachers' ethics, so that the construction of teachers' ethics can gradually move to the track of institutionalization, which is also the key to improve the effect of the construction of physical education teachers' ethics. Thirdly, we need to further improve the incentive mechanism. For those sports teachers with lofty morality and rigorous style, schools can give timely recognition and encouragement to form a better development atmosphere. Finally, in the process of strengthening the construction of teachers' morality, school departments can also actively construct a team of teachers' morality supervision and inspection, or let students evaluate the morality of physical education teachers, with the help of these means to build a perfect supervision mechanism, which can also play a warning role for physical education teachers, and further improve teachers' morality and accomplishment.

D. Strengthen the Integration of Teaching and Research

In view of the above shortage of teaching research, colleges and universities must change their consciousness, increase their investment in physical education teaching, actively encourage and support physical education teachers to carry out teaching research, so that they can absorb experience in the process of physical education teaching in a timely manner, so as to achieve the goal of improving the professional quality and ability of physical education teachers. Specifically, on the one hand, schools can carry out teaching research with the help of "old with new" and "transfer with help" by teachers with rich experience and higher qualifications, so as to further improve the teaching research effect, so that young teachers can get some experience and experience [5]. On the other hand, young teachers also need to strengthen their own learning in the process of development, and pay more attention to scientific
